in jail and that draft issue to them on the general County
fund for said sum.

of R. H. Fuller for \$1.25 } It is ordered by the Court that
R. H. Fuller be allowed the sum
of \$1.25 for lumber furnished for jail lot and David Reynolds
deceased and that draft issue on the Court House & Jail fund.

Reynolds In the matter of the account of October 15th 1890
of A. S. Wood for \$1.00 } It is ordered by the Court
that A. S. Wood be allowed the
sum of \$1.00 for hauling the corpse of David Reynolds
to the town yard and that draft issue on the general
County fund for said amount.

Reynolds In the matter of the account of October 15th 1890
of M. S. Parsons for \$5.00 } It is ordered by the Court
that M. S. Parsons be allowed
on his account of \$5.00 for digging grave for David Reynolds
deceased the sum of \$4.00 and that draft issue to him
on the general County fund for said amount.

In the matter of the account of October 15th 1890
of Messrs. Kinsom & Co for \$3.00 } It is ordered by the Court that Kinsom
& Co. be allowed the sum of \$3.00 for
and draft issue on the Court House & Jail fund

The Court reserving the right to reject any and all bids.

 & P. N. White Constable } It is ordered by the Court that the bonds of S. D. Dickson Tax Collector, H. W. Dickerson Constable, H. A. Wilson Tax Assessor and P. N. White Constable of Precinct No. One of Fitus County be and the same are hereby approved.

two days at this term of Court and G. B. Dinkson Sheriff be allowed
the sum of four dollars for waiting on this Court and that drafts
issue on the General County fund for said sums.

The business of the Court having been disposed of it is ordered
that Court adjourn.
