agree to use whiteliment fully $\frac{3}{16}$ joint and use the english bond or header of the same brick, making a more substantial bond than the bond header specified. 2nd That in consideration of the change from the more expensive St. Louis Buff Brick to a cheaper grade red brick - The Contractors allow a deduction of (\$1⁰⁰) Eleven dollar and fifty cents per m from the contract price. It is further agreed and ordered to be carried out all mantels and grates provided the contractors allow a deduction of (\$90⁰⁰) Nine dollar the cost of same from the contract price.

F. C. W. In the matter of the petition of June 19th 1896
to all pay of Court & Sheriff } It is ordered by the Court that
F. L. Wallers County Judge, W. J. Silafield, J. N. Brown and J. W. Myer Commissioners be allowed the sum of \$2⁰⁰ each for holding Court and that G. W. Dickson Sheriff be allowed the sum of \$2⁰⁰ for waiting on the Court and that drafts issue on the General County funds.

The business before the Court having been disposed of it is ordered that Court adjourn.
