 Assessor filed at this term of Court that the statistical report filed
 Court for H. A. Millam Tax Assessor
 of Tarrant County has been properly made
 out and that the same shows that there are 2017 tax payers
 or heads of families in Tarrant County. It is ordered by the Court
 that said Assessor be allowed the sum of ten cents for
 each tax payer or head of family in said report one half to
 be paid by State and one half by Tarrant County - and that draft
 issue to him on General County fund for 100.85 out of tax proceeds 1896

Issued In the matter of the account August 1st 1896
 of E. W. Dickson off for \$90.00 It is ordered by the Court that
 E. W. Dickson be allowed the sum
 of \$90.00 for writing on the County book, for office rent and postage
 to him on the General County fund.

Issued In the matter of the account August 1st 1896
 of D. E. Riddle for \$18.00 It is ordered by the Court
 that D. E. Riddle Constable of
 Precinct No. 1 - Tarrant County be allowed the sum of \$18.00
 for work done him in course of Tarrant County on Court house
 and that draft issued to him on General County
 fund for same -

Issued In the matter of the account August 1st 1896
 of J. L. Waller County Judge It is ordered by the Court that
 for \$45.00 J. L. Waller, County Judge be

allowed the sum of \$45⁰⁰ for disposing of fifteen cases in
County Court and that draft issue to him for same on the
Road and bridge fund -

In the matter of transferring August 18th 1896
\$500 from Road & Bridge fund to the jury fund
to the jury fund H. S. Webb County Treasurer is hereby
authorized and directed to transfer
\$500⁰⁰ of the Road & Bridge fund to the jury fund -

E. W. Dickson be allowed two dollars for waiting on the
Court and that drafts issue on the General County funds
