Presiding J. L. Waller County Judge of said County Board of W. F. Delafield, John A. Riddle, E. C. Brown and J. D. Myers Commissioners, G. B. Dickey Sheriff and A. E. Riddle County Clerk whereupon the following proceedings were had to wit:</p>
Issued	<p>In the Matter of the Statute ³ August 1st 1896 Report of H. A. Wilson Tax Assessor appearing to the Court aforesaid filed at the time of ³ that the statistical report filed by H. A. Wilson Tax Assessor of Titus County has been properly made out and that the same shows that there are 2017 tax payers or heads of families in Titus County. It is ordered by the Court that said Assessor to allow the sum of ten cents for each tax payer or head of family in said report one half to be paid by State and one half by Titus County and that draft issue to him on General County for \$100.00 out of taxes for 1896</p>
Issued	<p>In the Matter of the account ³ August 1st 1896 of G. B. Dickey Sheriff from ³ It is ordered by the Court that G. B. Dickey be allowed the sum of \$30⁰⁰ for waiting on the County Board for payment of draft issued to him in the General County fund.</p>
Issued	<p>In the Matter of the account ³ August 1st 1896 of A. E. Riddle from \$18⁰⁰ It is ordered by the Court that A. E. Riddle Comptroller of Precinct No. 1 Titus County be allowed the sum of \$18⁰⁰ for cost incurred in care of Titus County on County bonds and that draft issued to him on General County paid for same.</p>
Issued	<p>In the Matter of the account ³ August 1st 1896 of J. L. Waller County Judge ³ It is ordered by the Court that J. L. Waller County Judge be</p>

allowed the sum of \$45⁰⁰ for disposing of fifteen cows in
County Court and that draft issue to him for sum on the
Road and bridge fund.
