 J. M. Stringer and that drafts issue on the general fund

It is ordered by the Court that F. L. Waller County
 Judge be and he is hereby granted twenty days leave
 of absence.

In the matter of transferring County funds August 31st 1896
 It is ordered by the Court that
 S. J. Orth County Treasurer be
 and he is hereby authorized and directed to transfer
 \$1000.00 from the Court House and jail fund to the Roads
 & Bridge funds.

 Ed has for \$2⁰⁰ each It is ordered by the Court
 that J. H. Dixon, M. R. Edwards
 and Ed has be allowed the sum
 of \$2⁰⁰ each for examining stock supposed to be affected with
 glanders and that drafts issue on the General County funds

Secured In the matter of the account August 31st 1896
 of R. L. Rogers for \$7⁰⁰ It is ordered by the Court
 that R. L. Rogers be allowed
 the sum of \$7⁰⁰ for bank of matter and draft issue on Gen. funds

Secured In the matter of the account of August 31st 1896
 Aaron Smith for \$12⁰⁰ It is ordered by the Court
 that Aaron Smith be allowed
 \$12⁰⁰ for Affidavits and Informations and draft issue
 on the Court House & jail fund for same.

Secured for 14800 In the matter of the payments August 31st 1896
 of J. A. Wilson v. Contractors It is ordered by the Court
 for Court House that draft issue to J. A.
 Wilson v. for \$4300⁰⁰ amount
 payment on Court House when the work is completed and
 received by H. C. Barlow Superintendent, as specified -
 And it is further ordered that the Clerk issue draft
 on other payments as they become due and certified
 by said H. C. Barlow. And that the amounts in charge
 of brick and mortar to be deducted out of 3⁰⁰ or 4⁰⁰
 payments

Secured In the matter of the per diem August 31st 1896
 pay of Court & Sheriff It is ordered by the Court
 that G. L. Waller County

Judge, W. J. DeLaford, John A. Brune and J. W. Myers
Commissioner be allowed the sum of \$3⁰⁰ each for hold-
ing Court and that G. B. Bieder be allowed \$2⁰⁰ for
drafting on this Court and that drafts be issued on the Gen-
eral County funds for same -

it is ordered that Court adjourn until next regular time
