In the matter of the account of W. J. Adair for \$6⁰⁰ March 28th 1900
 It is ordered by the Court that W. J. Adair be allowed the sum of \$6⁰⁰ for letting and receiving bridge and that draft issue to him on the road and bridge fund for same -

In the matter of the account of T. E. Allen for \$2⁰⁰ March 28th 1900
 It is ordered by the Court that T. E. Allen be allowed the sum of \$2⁰⁰ for work on Post house and that draft issue on the General County fund -

In the matter of the account of R. W. Fuller for \$42¹⁸ March 28th 1900
 It is ordered by the Court that R. W. Fuller be allowed the sum of \$42¹⁸ for lumber, work, hauling &c for Small post house and that draft issue on the General County fund for said sum -

In the matter of the account of Story & Hudspeth for \$82⁰⁰ March 28th 1900
 It is ordered by the Court that Mess Story & Hudspeth editors of the Wide-awake be allowed the sum of \$82⁰⁰ for publishing the result of Local option in bookwise school District - and that draft issue to them on the General County fund -

Commissioners
Court of Teras County
and State of Texas

met in special session at the Court House thereof
in the town of Mt Pleasant, for the purpose of
opening the poll lists and counting the votes
of an election held in and for the following de-
scribed subdivision of Teras County, Texas to wit:
Beginning at N. A. Burkheads N.E. Corner -
Thence north with S.L. Wallers, S.E. Coenders
and Jim Franklin N.W. line to B. W. Griffin
S.E. Corner - Thence south with Shinking Creek
to W. H. Harpser S.W. corner - Thence east to Mr.
Brothers N.W., J. M. Staley, J. P. Johnson, Frank
Raney's and F. A. Raney's S.W. lines East to the
E.W. line of the Thomas Saltathite survey -
Thence North to the place of beginning -
Being the bounds of the Arga Independent
School District of Teras County, Texas -
Said election held on the 17th day of March 1900 -
at Arga by the qualified voters thereof, to deter-
mine whether or not the sale of intoxicating
liquors should be prohibited in said subdivi-
sion of Teras County, And it appearing to the
court from the returns of said election that
said election resulted in favor of the prohibition
of the sale of intoxicating liquors in said
subdivision of said County, and that 36
votes were cast for prohibition in said election
and 4 votes were cast against prohibition
in said election - It is therefore ordered,
adjudged and deemed by the Court that the
sale of intoxicating liquors be and the same
is hereby prohibited in said subdivision
of said Teras County, Texas, except for the
purpose and under the regulations specified
in the local option laws until such time as
the qualified voters therein at a regular
legal election held for that purpose by a

majority vote deem otherwise.

In the matter of the changes of the Mt Pleasant Road
 March 28th 1900
 It is ordered by the Court that the petition of Mrs. Sallie Tabb and others to change the Mt Pleasant and Leash road be granted upon the petitioners cutting out and opening out said change at their expense which change is as follows: Beginning $1\frac{1}{4}$ miles south of Mt Pleasant at a point in said road thence south 277 yds. to J. M. Tabb S.W. corner thence east 667 yds. to J. M. Tabb S.E. corner and intersecting said road about $1\frac{3}{4}$ miles from Mt Pleasant -
