was ordered by the court that the following tax be levied for  
Titus Co for the year 1908

10 cents on the \$1000 valuation of property in Titus Co for the jury  
fund.

15 cents on the \$1000 valuation of property in Titus Co,  
for the Road & Bridge fund.

15 cents on the \$1000 valuation of property in Titus County  
for the Court House & Jail fund

20 cents on the \$1000 valuation of property in Titus County  
for the General County fund.

And there is levied a special school tax on the  
following districts as follows:

School District No. 1 on the \$1000 valuation of property in said district

School District No. 2 on the \$1000 valuation of property in said district

School District No. 3 20 cents on the \$1000 valuation of property in said  
district

School District no 6 20 cents on the \$100<sup>th</sup> valuation of property in said district.

School District no 7 20 cents on the \$100<sup>th</sup> valuation of property in said district.

School District no 8, 20 cents on the \$100<sup>th</sup> valuation of property in said district.

To the Honorable Board of County Commissioners of Titus County, To wist:

We, your petitioners respectfully represent:

That the subscribers hereof constitute a majority of the inhabitants qualified to vote for members of the Legislature of the territory hereinafter described and desire such territory to be added to and become part of the Argo Independent School District:

That said territory proposed to be so added adjoins the limits of said Argo Independent School District is contiguous to one line of said corporation and is described by metes and bounds as follows:

Beginning in the County of Titus about ten miles North East from the town of Mt. Pleasant at the S. E. corner of Mrs. E. N. Williams fifty acre tract out of the Ben Clark H.R. Survey. Thence North with her E. B. line to her N. E. corner. Thence West with her N. B. line to her N. W. corner and B. L. Tigert's E. B. line. Thence North with said Tigert's E. B. line to his N. E. corner. Thence West with his N. B. line to R. V. Smith's S. E. corner. Thence North with said Smith's E. B. line to his N. E. corner Thence West with said T. A. Smith's N. B. line to his N. W. corner. Thence South with said T. A. Smith's W. B. line to the N. E. corner of M. W. Camerons 101 acre tract. Thence West with the said Cameron's N. B. line to his N. W. corner Thence South with the said M. W. Cameron's Tom Cameron's, Jas. Clark's and Mrs. Willie Parson's W. B. line to G. W. Pope's 100 acre tract the N. E. corner. Thence West with the said Pope's N. B. line to his N. W. corner. Thence South with the said Pope's W. B. line to Jas. Franklin's N. W. corner the N. B. line of Argo Independent School District.

That the Argo Independent School District as it now exists contains an acre of 1 less than 25 square miles and that the proposed addition will not increase the corporate limits of said district so that the whole when so increased will exceed 25 square miles.

To show the location of the territory proposed to be annexed with reference to the existing territory of said Argo Independent School District there is attached hereto as a part of this petition, a map showing the existing territory of said district and the territory proposed to be added thereto.

Wherefore we pray that said territory be added to and made a part of the corporate limits of said Argo Independent School District as provided for by Section 153 of Chapter 124 of the General Laws of the Regular Session of the twenty-ninth Legislature.
