Mitebe all County Clerk when the following proceedings were had:

In the matter of allowing accounts.

Sept 26th A. D. 1910 on this day came on to be examined the following accounts which were presented against the County by various parties, said accounts being examined by the court were found to be just and legal accounts. It is therefore ordered adjudged and decreed by the court that same be and they are hereby allowed and ordered paid.

In the matter of the application of Bettie Brown to be placed on pauper list.

Sept 26th A. D. 1910, On this day came on to be considered the application of Bettie Brown to be placed on the pauper list and it appearing to the court that said applicant is an old lady with out support and that she is unable to support her self. It is therefore ordered and adjudged and decreed by the court that she be placed on the pauper list and be allowed the sum of \$5.00 per month.

In the matter of dividing the Public Road of the county into convenient road precincts Sept 26th A. D. 1910, On this day came on to be considered the matter of dividing the public roads of the County into convenient road precincts as is required by the special road law of this County, and it appearing to the court that to divide the roads into precincts same as the voting precincts of the county making each voting precinct a road precinct and giving each road precinct the same number as the voting precinct would be convenient for all parties concerned both the road supt and road holders. It is therefore ordered adjudged and decreed by the court that each and every voting precinct be made a road precinct and that the boundaries of each voting precinct be the boundaries of a road precinct, and the various road precincts shall be described by metes and bounds as follows to-wit:

Read Precinct No. One.

Beginning at a point 4 miles due West from the center of the Court house in Mt. Pleasant Texas, Thence North to White Oak Creek--- Thence East with the meanderings of said creek to Black's crossing on the Mt. Pleasant and Clarkville road--- Thence South with said road to Mt. Pleasant passing through the city of Mt. Pleasant down what is known as Clarkville street thence on down Pittsburg street--- thence on down The Mt. Pleasant and Pittsburg road to Cypress Creek /--- Thence up said Cypress Creek to a point due south of the place of Beginning--- Thence North to place of Beginning.

Read Precinct No. 2. Greerhill

Beginning at Evans Bridge on White Oak Creek--- Thence South with the said Evans Bridge and Mt. Pleasant Road same being W. B. Line of Arge Justice Precinct. to North Boundary line of Voting precinct No. Eight (Mt. Pleasant East Side) Thence West with N. B. line of Voting precinct No. eight and N. B. Line of Voting precinct No. One to Marshall Springs Voting precinct No. 3--- Thence North with E. B. Of said Voting precinct No. 3 to White Oak Creek--- Thence East with the meanderings of said White Oak Creek to Evans Bridge the Place of Beginning.

Read Precinct No. 3. Marshall Springs.

Beginning at a point in W. B. Line of Precinct No One in Mt. Pleasant and Mt. Vernon Public Road--- Thence North with the W. B. line of Justice Precinct No. One to White Oak Creek--- Thence West with the Meanderings of said Creek to Franklin County E. B. line--- Thence South with the E. B. line of Franklin County and W. B. line of Titus County to a point where said line crosses New Hope and Daphne Public Road--- Thence East with said public road to Ripley Creek -- Thence South with the meanderings of said creek to Bridge on Mt. Pleasant and Mt. Vernon Public Road--- Thence East with said road to place of Beginning .

Read Precinct No. 4. Menticelle

Beginning at a point in W. B. line of Justice Precinct No. One in the Mt. Pleasant and Hepswell road--- Thence West with said road to W. B. Line of Titus County and E. B. line of Franklin County--- Thence South with Franklin county E. B. line and Titus County W. B. line to Cypress Creek--- Thence East with Meanderings of said creek to Cypress Creek to W. B. line of Precinct No One--- Thence North with W. B. line of Justice Precinct No. One to place of Beginning.

Read Precinct No. 5. Maple Springs.

Beginning at a point in White Oak Creek of Morris County where same crosses White Oak Creek Thence West with the meandering of said Creek to E. B. Line of Geolebers Voting precinct Thence North with the said E. B. Line of said Geolebers voting precinct to Sulphur River Thence East with said Sulphur River to W. B. Line of Morris County--- Thence South with W. B. line of Morris County and E. B. Line of Titus County to place of Beginning.

Road Precinct No. 6. Coakville.

Beginning at a Point in Merrie County Line due East of the S. E. Cor of the George Clapham Survey--- Thence West with said South N. line of said Sy. to S. W. Cor of same--- Thence West to Mt. Pleasant and Daingerfield Road--- Thence West to E. B. line of Justice Precinct No. One--- Thence N. with E. B. Line of Justice Precinct No. one to Liberty Hill and County Line Road at Widow Crawford's place--- Thence East with said Road to Coakville and Ellis Bridge Road--- Thence East with Liberty Hill and Merrie County Line Road to W. T. Ryan's N. W. Cor. Thence S. with his W. B. line to his S. W. Cor--- Thence East with W. T. Ryan's S. B. line and Jno. Denny's S. B. to Coakville and Lone Star Road--- Thence South with Said Coakville and Lone Star Road to S. W. Cor. of Sam Merriett's Survey--- Thence East with S. B. line of said Survey to J. A. Dale's N. W. B. line Thence N. with E. B. of Merriett's Survey to Dale's N. W. Cor. Thence E. with Dale's N. B. line and on E. between W. A. Wright and Temple Smith places to Merrie County Line --- Thence South to place of Beginning.

Road Precinct No. 7. Hickory Hill

Beginning at a point in Merrie County Line due East of the S. E. Cor. of the George Clapham Survey--- Thence West with S. B. line of said Survey to S. W. Cor of same--- Thence West to Mt. Pleasant and Daingerfield and Mt. Pleasant Road--- Thence West to E. B. line of Mt. Pleasant Justice Precinct No. One Thence South with E. B. Line of Justice Precinct No. one to Cypress Creek Thence East with the meanderings of said creek to W. B. line of Merrie County Thence North with W. B. Line of Merrie County and E. B. line of Titus County to place of Beginning.

Road Precinct No. 8. Mt. Pleasant East Side

Beginning at a point 4 Miles Due East of the Center of the Court House in Mt. Pleasant, Texas Thence South to Cypress Creek--- Thence West with the Meanderings of said Creek to Bridge on Mt. Pleasant and Pittsburg Road--- Thence North with said Mt. Pleasant and Pittsburg Public Road to City of Mt. Pleasant--- Thence Through the said City of Mt. Pleasant through what is known as Wittsburg and Clarkville Streets--- thence on North with the Mt. Pleasant and Clarkville public Road to S. B. line of Green Hill Voting precinct--- Thence East with said S. B. line of said Green Hill Voting precinct to a point due North of a Point 4 Miles Due East of the center of said Court House--- Thence South to place of Beginning.

Road Precinct No. 9. Geolosphere.

Beginning in the E. B. Line of Franklin County where same crosses White Oak Creek Thence East with Meanderings of said Creek to W. B. line of Maple Spgs Voting Precinct--- Thence North with W. B. line of said Maple Spgs Voting Precinct Sulphur River--- Thence West with said Sulphur River to E. B. line of Franklin Co.--- Thence South with the E. B. line of Franklin Co. to Place of Beginning.

Road Precinct No. 10. Argo.

Beginning at Ellis Bridge on White Oak Creek--- Thence South the Ellis Bridge and Cooper's Chapel Road to Liberty Hill and Merrie County Road at Liberty Hill Church--- Thence West with the Liberty Hill and County Line Road to Harts Bluff Road at Mrs. Crawford's place--- Thence North with Harts Bluff Road to White Oak Creek--- Thence East with the Meanderings of said White Oak Creek to place of Beginning.

Road Precinct No. 11. Winfield.

Beginning at a point in the W. B. line of Justice Precinct No. 1. in the Mt. Pleasant and Mt. Vernon Road--- Thence West with said Mt. Pleasant and Mt. Vernon road to where same forks about 400 yards beyond A. F. King's--- Thence West with left hand fork of same known as the South Park Bridge Road to Ripley Creek--- Thence North with the Meandering of said Creek to Bridge on New Hope and Daphne Public Road--- Thence West with said New Hope and Daphne Road to E. B. Line of Franklin County--- Thence South with said E. B. line of Franklin County and W. B. line of Titus County to where same crosses Mt. Pleasant and Hepewell Road--- Thence East with said Mt. Pleasant and Hepewell Road to W. B. Line of Justice Precinct No. 1. Thence North with the W. B. line of Justice Precinct No. 1 to place of Beginning.

Road Precinct No. 12. Lone Star.

Beginning at Coakville & Ellis Bridge road at Liberty Hill and Merrie County Road--- Thence West with Liberty Hill and Merrie Co. Road to W. T. Ryan N. W. Cor. Thence S. with his W. B. line to S. W. Cor. --- Thence East with W. T. Ryan's S. B. line and Jno. Denny's S. B. line to Coakville & Lone Star Road--- Thence South with Coakville and Lone Star Road to S. W. Cor of Sam Merriett Survey--- Thence East with Merrie Co's S. B. line to J. A. Dale's N. W. Corner --- Thence East with Dale's N. B. line and on East Between W. A. Wright and Temple Smith places to Merrie County line--- Thence North with Merrie County line to White Oak Creek--- Thence West with White Oak Creek to Ellis Bridge on said Creek--- Thence South with said White Oak Creek to Coakville & Ellis Bridge Public Road to Place of Beginning.
