

But it is remembered that the Commissioners Court of Titus County Texas convened in regular session at the Court House in the town of Mt. Pleasant, Texas on Monday, Aug 10th 1914 - with County Judge Sam Potter, Present and Presiding and also were several County Commissioners Brown, Cameron, and Thompson.

August 11th 1914 came on to consider the matter of adjusting the boundary line between Justice Precincts Numbers 4 & 7 as follows to wit: So all of the Territory East of Coopers Creek and Ellis Bridge road between the intersection of said and South boundary line of Justice Precinct Number 9. to Coopers Cheffer where said interests what is known as Doer's Cook road - thence with said Cook road to Rose Creek. It being intended to place the Territory East and South of said roads shall be placed in Justice Precinct No 4. Justice Precincts Numbers 10 & 12 are changed to contain Territory in accordance with above line - the above changes ordered made.

Smith on September 12th, 1914, I now give notice to all persons that said election will be held at the time and place above stated for the purpose of submitting to the qualified property taxpaying voters of said district the question of the levy of a special tax in said district of not to exceed FIFTY CENTS upon each One Hundred Dollars Taxable valuation of property in said district per annum for the purpose of supplementing the State School fund appropriated to said district.

 levy of a tax of not to exceed 50 cents on each one hundred dollars
 taxable valuation of property in said district for account
 for the purpose of supplementing the state school funds
 appropriated to said district.

I appoint S. B. Smith, presiding officer of said election and
 Ed Claborn associate judge and Ollie Claborn clerk.

I order the sheriff of Titus County to give notice of this
