

Be It Remembered that the Commissioners Court of Titus County Texas met in a regular session at the Court House of said County in the City of Mt. Pleasant Texas on the 14th day of October A.D. 1918 with the following members present to wit:

J. W. Tubb, County Judge, Smart Boyant King and Cameron, County Commissioners of Titus County Texas, J. Commissioners Precincts Numbers 1-2-3-4 respectively, and C. T. Hargrett County Clerk

When came to be considered by the Court, the matter of the returns of a special election held within school district Number 1 of said County, whereupon County Commissioner Boyant offered the following ~~to~~ to the Commissioners Court of Titus County Texas and made a motion that the same be passed by the Court, which motion was seconded by County Commissioner Smart.

The order is as follows to wit:

It appears to the Commissioners Court of Titus County Texas, that heretofore as ordered by this court, a special election was held in Common School District No. 1 of Titus County Texas, on the 14th day of ^{September} August A.D. 1918, on the question of the issuance of the coupon bonds of said district to the amount of \$1,000⁰⁰, bearing 5% interest per annum from date until paid, due and payable 20 years after date, with the option of redemption at anytime after one year from date, for the purpose of constructing and equipping a public free school building within said district, and the levy, assessment and collection of an annual tax against all taxable property within said district, of a rate sufficient to pay the principal and interest on said bonds as they shall mature, that there were cast at said election 20 votes "For the issuance of bonds" and that there were cast at said election "Against the issuance of bonds" 8 votes.

It also appears that a majority of the votes cast at said election were cast in favor of the issuance of said bonds and the levy, assessment and collection of said tax.

It is therefore ordered, adjudged and decreed by the Commissioners Court of Titus County Texas, that said election resulted in favor of the issuance of said bonds and the levy, assessment and collection of said tax.

The County Judge put said motion for a vote of the members of the Commissioners Court of Titus County Texas, with the request that as many as favored the motion to vote "Aye", and all those opposed the motion to vote "No". County Commissioners, Leonard Bryant, King and Cameron voted "Aye". None voted "No". The County Judge declared the motion carried and the order passed.

The foregoing minutes of the Commissioners Court of Titus County Texas, read and approved this October 14th, A.D. 1918.

J. W. Fable, County Judge, Leonard Bryant, King and Cameron, County Commissioners, Commissioners President, Numbers 1, 2, 3, and 4 of Titus County Texas, respectively and County Clerk, C. T. Neugeant.

When came to be considered by the court, the matter of the issuance of the coupon bonds of Common School District Number 5 of Titus County, Texas where County Commissioner Bryant offered the following order to the Commissioners Court of Titus County Texas and made a motion that the same be passed, which motion was seconded by County Commissioner Leonard. The order is as follows to-wit: -

"It appears to the Commissioners Court of Titus County Texas, that at a special election held within Common School District Number 5 of Titus County Texas on the 14th day of ^{September} 1918, a majority of the resident property tax-paying voters residing within said district, voting at said election, voted in favor of the issuance of the coupon bonds of Common School

District Number Five of Titus County Texas and the levy assessment and collection of a tax against all taxable property within said district of a rate sufficient to pay the principal and interest of such bonds as they shall mature, as hereinafter described.

It is therefore ordered, adjudged and decreed by the Commissioners Court of Titus County Texas that the Coupon Bonds of Common School District Number Five of Titus County to be called 'School House Bonds of Common School District Number Five of Titus County Texas,' be issued to the amount of Fifteen Hundred dollars.

They shall bear date October 10th 1918, bear interest from date until paid at the rate of 5% per annum until paid payable annually on April 10th each year which will be evidenced by interest coupons attached to said bonds, signed by written printed or lithographed signatures of the County Judge and County Clerk of Titus Texas. Both principal and interest shall be payable to bearer at the office of the County Depository of Titus County Texas or at the office of the Treasurer of the State of Texas, at the option of the holder, such bonds will be due and payable twenty years after date with the option reserved to the district to redeem and pay them at any time after one year from date, and they shall be signed by the County Judge and County Clerk of Titus County Texas.

The Bonds shall be in substantially the following form to-wit:

School House Bonds of Common School District Number Five of Titus County Texas.

Twenty years after date, for value received, Common School District Number Five of Titus County Texas promises to pay to bearer, at the office of the County Depository of Titus County Texas or at the office of the Treasurer of the State of Texas, at the option of the holder, the sum of One Hundred Dollars together with interest thereon, at the rate of 5% per annum

from date until paid, payable on April 10th each year,
which interest is evidenced by interest coupons hereto
attached

This is one of a series of bonds numbered from 1 to 10
both inclusive issued by Common School District Number
Five of Titus County Texas, by virtue of the authority
of the Constitution and Laws of the State of Texas, and
election held within said district on ^{November} ~~August~~ 10th A.D.
1918 whereat a majority of the resident qualified voters
of said district, voting at said election, voted in favor
of the issuance of such bonds, and the levy, assessment
and collection of an annual tax against all taxable
property within said district of a rate sufficient to pay
the principal and interest of such bonds as they shall
mature, and an order passed by the Commissioners
Court of Titus County Texas - and entered in its minutes.

The option to redeem and pay off this bond and all
interest due thereon at any time after one year from
date is reserved to said district and should the
district elect to exercise such option it will cause
written notice of such intention to be given to each
of said places of payment for 30 days prior to the date
it will pay such bond and interest thereon and
should the holder of such bond not advise the dis-
trict in time to place the funds at which of said places
payment is desired to be made this bond shall cease
to bear interest from after the date so fixed for its
redemption and payment.

It is recited and certified that each and every
condition precedent required by the Constitution
and Laws of the state of Texas to be done and perform-
ed prior to the issuance of said bonds has been done
in the time and manner required and that no
limitation of either such laws has been or will be ex-
ercised in the issuance of this bond. It is further certified
that due and proper provision for the payment of
this bond and the interest thereon has been made by
the levy of a tax against all taxable property within
said district.

For the purpose of paying the interest on said bonds as it accrues, and to create a sinking fund with which to pay the principal thereof at maturity, there is levied against all taxable property within Common School District Number Five of Titus County Texas, for the year 1918, and each and every year thereafter, while said bonds or any part thereof, are outstanding and unpaid, a tax of twenty-five cents upon each and every one hundred Dollars valuation thereof, which tax is ordered assessed and collected and appropriated exclusively to the purposes named.

The County Judge put the motion for a vote of the members of the Commissioners Court of Titus County Texas with the request that as many as favored the motion to vote "Aye", and those opposed to vote "No". County Commissioners Smart, Boyant, King and Cameron voted "Aye" None voted "No". The County Judge declared the motion carried and the order passed.

The foregoing minutes of the Commissioners Court
