

Be it remembered that there was a regular and holden a regular term of the Commissioners Court of Titus County, Texas, on this the 8th day of Dec. 1919, with the following officers and members present to wit: J. O. Gable, County Judge, A. R. Smart, W. M. King, W. A. Lee and T. A. Brown, Commissioners, and G. M. Nugent Clerk.

Court was opened by a proclamation of the Sheriff of Titus County, Texas.

In the matter of allowing }
funds for Utility Trucks } Dec. 8th 1919,
County Commissioner, Smart made a motion, which motion was seconded by Commissioner Brown; that an account from the State Highway Department amounting to the sum of \$344.⁰⁰ for rent and delivery of two Nash Load Trucks furnished by the U. S. Government through the State Highway Department said trucks to be used in maintaining the Public Roads and Highways in Titus County, and that the County Clerk drew a warrant, as provided by law, upon the funds derived from automobile taxes, now in the Treasury of Titus County, Texas, for said sum of \$344.⁰⁰. County Judge Gable, put the motion for a vote of the members of the Commissioners Court of Titus County, Texas with the request that as many as favored the motion to vote "aye" and those opposed to vote "no" Commissioners, Smart, Lee, King and Brown voted "aye" The County Judge declared the motion carried.

On this the 8th day of Dec. 1919 came on to be considered by the Commissioners Court of Titus County, Texas the matter of appointing a live stock inspector for Justice Precinct # 3 Titus County, Texas, where Commissioner

King made a motion that J. H. White be appointed Live Stock inspector in and for Precinct No. 3, Titus County, Texas, and that he be paid a salary of twenty five Dollars per month out of the General County funds of Titus County, Texas. Said motion was seconded by Commissioner Smart. County Judge J. W. Cobb put the motion for a vote of the members of the Court with the request that as many as favored the motion to vote "aye" and those opposed to vote "no". Commissioners King, Smart, Lee and Brown voted "aye". The County Judge declared the motion carried and the order passed.

Be it remembered that the Commissioners Court of Titus County, Texas, met in a regular session on the 8th day of December, A.D. 1919, at the Court House of Titus County, Texas, with the following members present to wit: County Judge, J. W. Cobb, County Commissioners, Smart, Lee, King and Brown, and Court Clerk, C. M. Neugent.

Court having been opened by proclamation of the Sheriff of Titus County, Texas, County Commissioner Smart, opened the following order to the Commissioners Court of Titus County, Texas, and made a motion that the same be passed by the Court, which motion was seconded by County Commissioner Brown. The order is as follows to wit:

It appears to the Commissioners Court of Titus County, Texas, that the bond of the First National Bank, as County Depository to cover additional funds which have come into the Treasury of said County, Texas, by reason of the issuance and sale of bonds of said County to the amount of \$576,000.00 has been made and executed in the manner, form and time provided by law and that the same is signed by ample, good and sufficient surety.

It is therefore, ordered by the Commission

Court of Titus County, Texas, that said bond, payable to Titus County, Texas for the sum of \$578,000.00, signed by First National Bank of Mt. Pleasant, Texas, as principal, and by the persons signed thereto as sureties, be and the same is, now in all things approved.

The County Judge put the motion for a vote of the members of the Commissioners Court of Titus County, Texas, with the request that as many as favored the motion would vote "ay" and all those who opposed the motion to vote "no". County Commissioners Smart, Lee, King and Brown, voted "ay". None voted "no". The County Judge declared the motion carried and the order passed.

The foregoing minutes of the Commissioners Court read and approved this the 8th day of Dec. A.D. 1919.
