Be it remembered that on this the 8th day of March a.D. 1920, there was begun and holden a regular term of the Commissioners Court of Titus County, Texas at the Court House thereof in the City of Mt. Fleasant. with the following members present to wit: J.W.Tabb. County Judge, A.P.Smart, W.M.King, T.B.Brown and J.A.Lee, Commissioners and C.T.Neugent, Clerk. Court was opened by a proclamation of the Sheriff of Titus County, Texas.

In the matter of transferring ! funds from C.H. and J. to Gen. Co. fund.

On this the 8th day of March 1920, Commissioner Smart offered the following order to to the Commissioners Court of Titus County Texas, and made a motion that the same be passed by the court, which motio. was seconded by Commissioner Lee. It appears to the Commissioners Court of Titus County, Texas that it is necessary to transfer the sum of Three Thousand Dollars from the Court House and Jail Eund of Titus County Texas to the Jeneral County fund of Titus County Texas. Motion put . Smart, Lee, King and Brown vote "Aye" none voted "no". County Judge J.7. Tabb declared the motion corried and the order passed.

Prisoners Transferred to Samp or Franklin Co.

Commissioner Smart made a motion, which motion was seconded by Commissioner Aing; that the Prisioners now in the County Jail of Titus County be transferred to either Franklin or Camp Counties on account of the heating plant at the jail being out of running order. County Judge put the motion for a vote of the members of said court with the request that as many as favored the motion to vote "Aye" and those opposed to vote "no". Sommissioner Smart, King, Lee and Brown vote "sye" none voted "no". County Jud ge declared the motion carried and the order passed.

County Commissioner Smart offered the following order to the Commissioners Court of Titus County, Texas and made a motion that the same be passed, which motion was seconded by Commissioner King. The order is as follows, to wit:

It appears to the Commissioners Court of Titus County, Texas that it is necessary for Titus County to employe the ollowing named persons atm the following named salaries to work on the Public Highways and roads of Titus County, to wit: Pen Brook to be paid the sum of \$95.00 per month, John Garrett to be paid the sum of \$85.00 per month, C.W.Otwell to be paid the sum of \$75.00 per month, and C.F. Hays to be paid the sum of 475.00 per month. Said amounts to be paid out of the Automobile Fund of Titus County, Texas on the first day of Each month; that the County Clerk of Titus County be authorised to draw a warrant to each of the above named parties for the respective amounts out of the automobils Fund of Titus Co., on the lat day of each month. County Judge .J. J. Tabb put the motion for a vote of the members of the Commissioners Court of Titus County with the request that as many as favored the motion to vote "Aye" and those opposed to vote "no".Commissionessiment, King, Lee and Brown woted "eys" none woted no. County Judge J. J. Tabb declared the motion carried and the order passed.
