IN MATTER OF TICK ERADICATION

IN TITUS COUNTY TEXAS.

On this the 12th day of July A.D.1920 came on to be considered by the Commissioner's Court of Titus Count, Texas the matter of taking up tick eradication for Titus County when Commissioner. Smart made a motion that the court take up the tick eradication work thru out Titus County, and that each county commissioner of said County employ a suitable MAN to look after and superintend the matter of cattle dipping in his respective commissioner precinct, which motion was seconded by commissioner King.

The County Judge put the motion to the members of the commissioners court of Titus County Texas with the request that as many favored the motion say Aye and those that oppose say No, the vote was as follows: Smart, aye, King Aye, Lee No, and Brown No., County Judge J.W.

Tabb voted Aye. The County Judge declared the motion carried and the order passed.

THE MATTER OF EMPLOYING MEN TO SUPERINTEND CATTLE DIPPING FOR TITUS COUNTY.

County Commissioner Smart effered the following order to the Commissioners Court of Titus County, Texas, and made a motion that the same be passed by said court, which motion was seconded by Commissioner King.

Thereas on this day the Commissioners Court of Titus County, Texas, directed that each County Commissioner of said county employ a suitable man to superintend cattle dipping in their respective Precincts.

And whereas, Commissioner Smart has employed Bob Slayton to superintend and supervise the dipping of cattle in Commissioners Precinct Ec. 1., of Titus County.Texas., and that Commissioner Lee has employed H. G. Campbell to superintend and supervise cattle dipping in Commissioners Precinct Ho. 2 of Titus County, Texas, and Commissioners King has employed T. T. Polk to superintend and supervise cattle dipping in commissioners Precinct Ho. 3 of Titus County Texas, and Commissioners Precinct Ho. 3 and supervise cattle dipping in Commissioners Precinct Ho. 4 of Titus County. Texas.

and whereas each of eaid commissioners has agreed to pay each of eaid amployees \$100.0 e per month for said services

It is therefore ordered by the Commissioners Court of Titus County Texas and of said employments be much in all things ratified and confirmed, and that said ealaries be paid upon bills presented by said employees as required by law.

of Titue County Judge put the motion for a vote of the members of the Commissioners Court of Titue County Texas with the request that as many favored the motion vote "Aye" and those oppose vote "Ho". Commissioner Smart voted "Aye". King "Ho" Lee "Ho". Who was a work of the motion carried and the order passed.
