Court was opened by a proclamation by the Sheriff of Titus County, Texas when the following proceedings were had to wit:

Commissioner Smart made a motion that Henry Allen be allowed the sum of \$8.50 per month in addition to the \$15.00 per month that he has been receiving, making a total of \$17.50 per month. Said amount to be paid out of the General County fund of Titus County on the 15th day of each month and to begin on the 15th day of July 1920, seconded by Commissioner King. Motion put. vote as follows: Smart "Aye" King "Aye" Brown "Aye" and Lee "Aye". The County Judge declared the motion carried and the order passed.

Motion put. vote as follows: Smart "Aye" King "Aye" Brown "Aye" Lee "Aye". The County Judge declared the motion carried and the order passed.

IN THE MATTER OF FIXING |  
THE TAX RATE FOR YEAR. |

On this the 9th day of August 1920 commissioner Smart made a motion that the tax rate for Titus County Texas for the year 1920 be fixed and levied as follows:

General County Fund 25 cents upon the \$100.00 valuation upon real and personal property.  
Road and Bridge Fund 15 cents upon the \$100.00 valuation upon real and personal property.  
Jury fund 15 cents upon the \$100.00 valuation upon real and personal property.  
Court House and Jail Fund 15 cents upon the \$100.00 valuation of real and personal property.  
Special Road Fund \$1.70 upon the \$100.00 valuation of real and personal property.  
All Special School Tax to remain as heretofore levied by the Commissioners Court of Titus County, Texas. Motion seconded by Commissioner King, Motion put. vote as follows: Smart "Aye" King "Aye" Brown "Aye" and Lee "Aye" The County Judge declared the motion carried and the order passed.
