On this day came on to be heard by the commissioner court offitus County Texas, accounts be allowed when Commissioner Olds made a motion and same seconded by commissioner King that said accounts to be allowed as same entered in volume 2, minutes of accounts allowed page 113 to 15 inclusive. The county Judge put the motion before the said members of said court, with the request that as many as favored said motion to vote "I" and those opposed to vote "N". Commissioner King, Flemings, Old, and Edwards all voting I. The... County Judge declared the motion carriedand the order passed and directed the county Clerk to issue warrants for same.

In the matter of Bonds of County Officials.

Taylor as County Health officer in and for Titus County, Texas, for the year of 1932 which said appointment shall expire at the mext regular Pebruary Torm of the commissioners court of Titus County Texas, same being February 1925. County Judge put the motion before said members of said court with the request that as many as favored said motion to vote Ayé, and those opposed to vote No. Commissioner King, Old, Edwards and Flemings all voting Aye, the county Judge declared the motion carried and the order passed.

IN THE MATTER OF PURCHABING FORDSON TRACTOR FOR SAID COUNTY.

Motion by Commissioner Edwards Seconded by Commissioner Flemings that E.H.Horton, Highway Superintendent of Titus County, Texas, be authorised to employ men with teams not to exceed five in number, unless otherwise ordered by this court. At a daily wage of man and team nother exceed \$4.00 per day; \$0 work at stated intervals when in the Judgment of the court the work is necessary. The county Judge put the motion before said members of said court with the request that as many as favored said motion to Vote Aye, and those opposed to Vote. No. All commissioners voting Aye, the County Judge declared the motion carried and the order passed.

IN THE MATTER OF ALLOWING FRED FISHBACK CATTLE INSPECTOR BACK PAY.

Notion by commissioner King, and seconded by commissioner Edwards, that Fred Fishback Cattle inspector be allowed the sum of \$25.00 back pay for service rendered for dipping cattle. The county judge put the motion before said members of said court with the request that as many as favored said motion to vote Aye, and those opposed to vote No. All commissioner voting Aye, the County Judge declared the motion carried and the order passed.

IN THE MATTER OF GRANTING PUBLIC ROADS.

Motion by commissioner Edwards, and seconded by commissioner Old, that the order hereto made to the affect that no more public roads granted untill said roads be out out and fences set back so that said road shall be 40 feet wide is hereby recinded.

The county judgs put the motion before said members of said court with the request that as many as favored said motion to vote Aye, and those opposed to vote No. All commissioners voting Aye, the county judge declared the motion carried and the order passed.

IN THE MATTER OF APPOINTING JURY OF VIEW OF FUELIC ROAD.

Notion by commissioner King and seconded by commissioner Flemings, that this court appoint five citizens according to law as a jury of view consisting of the following men, J. Bohultz, C.T. Mitchmer, J.H.Cargile, A.B.Flanagen, and C.F.O'Dea, to view and lay out and mark the following road, beginning at a point in highway in Antone's North boundary

line; thence East by D. Olivere place intersecting Pad Harris road. It is hereby ordered that in case the road is granted by this court in the event right of way in not out out 40 feet wide and the fences set back 40 feet then the order granting the said road shall be of no effect after September 1st., 1922 and the road shall be as killed. The county Judge put the motion before said members of said court with the request that as many as favored said motion to vote Aye, and those opposed to vote No. All commissioners voting Aye, the county Judge declared the motion carried and the order passed.

IN THE MATTER OF THE COUNTY FEEDING FEDERAL PRISONERS.

Motion by commissioner King, seconded by commissioner Edwards, that the County Clerk be directed and notify ther sheriff of Titus County, Texas by delivering a copy of this order to him that hereafter Titus County will not under any circumstance pay board bills, medicine bills, Doctor Bills or any other expense of whatsoever nature incurred by the reason of the confinement of prisoners under Federal authority or Jurisdiction or any expense whatsoever incurred by reason of the confinement of prisoners other than those contemplated in article 7128 revised statutes. It is further ordered and directed by the court that the sheriff shall show by underlining with red ink the names of all persons excepted for confinement from all persons or officers other than the officers of Titus County or where it shall appear that the courts of Titus County Shall have jurisdiction of the trial of the person to be confined. The county judge put the motion before said members of said court with the request that as many as favored said motion to vote Aye, and those opposed to vote No. All commissioners voting Aye, the county Judge declared the motion carried and the order passed.

IN THE MATTER OF ALLOWING EX-OFFICIO SALARIES.

On this day came on to be considered by the commissioner sourt of Titus County, Texas, the matter of allowing Ex-Officio salaries for the following named officers: County Judge D.M.Cook \$1400.00 per year; Sheriff \$550.00 per year; County Clerk \$500.00 per year; Ex-officio and \$200.00 per year for keeping records and finance lodger; District Clerk \$550.00 per year; And itsis further ordered by said court that the county clerk shall issue warrants the first day of each month to each of said above mentioned officers. The county Judge put the motion before said members of said court with the request that as many as favored said motion to vote Aye, and those opposed to vote No. All commissioners voting Aye, the county Judge declared the motion carried and the order passed.

IN THE MATTER OF NOTIFYING THE BONDSMEN OF MRS. TOM PRICE EX-TAX COLLECTOR.

On this day came on to be heard and considered by the commissioners court of Titus County, Texas, the matter of notifying the sondsmen of Mrs Tom Price Ex-Tax Collector of Titus county Texas, when it appearing to said court that there was a deficiency in the funds due said county, under the administration of said Mrs. Tom Price, as Tax Collector. Commissioner Old made a motion seconded by commissioner Flemings that the County Clerk notify the bondsmen of said Mrs. Tom Price as Tax Collector to come in and make settlement on shortage as indicated in auditors report. The County Judge put the motion before

said members of said court with the request that as many as favored said motion to vote Aye, and those opposed to vote No. All commissioners voting Aye, the county Judge declared the motion carried and the order passed.

IN THE MATTER OF CREATING A FUND KNOWN AS TREASURER FUND.

On this day came on to be considered by the commissioners of Titus County, Texas, the matter of creating a fund known as treasurer fund, when commissioner King made a motion seconded by commissioner Flemings that the Treasurer's fund be created upon which Excofficio vouchers will be drawn, and vouchers for emergency accounts such as for assistance to paupers, GaO.D. shipments, janitor service, Freight, and that expenses ets for the county may also be charged to this account by the treasurer upon application of the county Judge. It is ordered by said court that the County Treasurer of Titus County, Texas, is hereby authorized to place to the credit of this fund all moneys collected from the State Mational Bank. The First Mational Bank, The Guaranty State Bank, the Bondsmen of J.M.Keith, former Tax Collector and the bondsmen of Mrs Tom Price Ex-Tax Collector. The county Judge is authorized to transfer such moneys as is necessary to take care of the aforesaid warrants. The county Judge put the motion before eath members of said court with the request that as meny as favored eath motion to vote Aye, and those opposed to vote No. All commissioners voting Aye, the county Judge declared the motion carried and the order passed.

IN THE MATTER OF APPROVING OFFICERS QUARTERLY REPORTS.

IN THE MATTER OF PROVING OFFICERS EXPENSE ACCOUNTS.
