RE IT REMEMBEREDThat there was begun and holden a regular Term of the Commissioness Court in and for Titus County, Texas, on this the 86h day of May, 1922, with the following officer present to-wit; Hon Dan M.Cook, County Judge, Commissioners W.H.King, W.H.Edwards, L.H Old and W.A.Fleming, and Clerk, Ulman Brown, when the following proceedings were had to wit;

Court open by proclamation by the Sheriff of Titus County, Texas, Jno. j Reeves.

In the matter of Convicts working on Road,

On this day came on to be considered by the Commissioners Court of Titus
County, Texas, the matter of persons eweing finds to said County for misdemeaner cases
that has not been paid and to be paid by defendants, when Commissioner King made
a motion and second by Commissioner Edwards, that here after all persons oweing finds
to said County and unable to pay same be put under supervision of B.B.Garrett who is to
paid at the rate of \$100.00 per month less 40 cents per day for board for his service
and said Garrett use this labor on all by roads in this County, until further order
of this Court, The County Judge put the motion before the members of said Court for
a vote with the request that as many as favored said motion to vote "Aye" and those eye
pose to vote "no" Commissioners King, Fleming, Old and Edwards all voted "Aye" the

County, Texas, the matter of appointing a Home Demonstration Agent, for said County, Mrs.R.F.Lindeay, et al, asking the this Court to appoint said Agent, Commissioner Edwards made a motion second by Commissioner King, that Mrs. Beulah Murphree be appointed County Farm Home Demonstration Agent at a salary of \$1000.00 per year, warrants to be issued the first of each month for said service, on the General County Fund, The County Judge put the motion before the members of said Court for a vote with the request that as many as favored said motion to vote "Aya" and those oppose to vote "Mof Commissioners King, Fleming and Edwards voted "Aye" and Commissioner Old voted "No", The County Judge declared the motion carried and the order passed.

Order appropriating Fands for Cooperative Extension Work.

State of Texas

County of Titus Commissioners Court of Titus County, in session May Term, A.D.1922.

The Commissioners Court of Titus County being desirous of promoting a more profitable method of agriculture and of assisting in the development of more comfortable and convenient rural homes in the County, is of the opinion that a agent should be employed to assist in said work, and in as much as the U.S.Department of agriculture, through the Extension Service of the A.M. College of Texas, will conduct Extension Work in this county provided the Commissioners' Count of the County will cooperate financially, the court is of the opinion that it should make an appropriation to supplement the funds of the Extension Service of the A. and M College of Texas in conducting such work in accordance with the general laws of Texas.

It is, therefore, ordered by this Court that the sum \$1000.00 be appropriated and the same is hereby appropriated out of the funds of Titus County, to assist in promoting a better method of agriculture and the development of more comfortable and convenient raral homes in Titus County.

This appropriation shall become available on April 1st, 1922, or as soon thereafter as the Extension Service of the A.M. College of Texas shall place an agent in said County of for duty, and shall be paid out in monthly installments to said agent upon written order duly signed by an authorized representative of said Extension Service. This order covers the expenditure of \$1000, prorated over a period 12 months.
