No? one in and for Titus County, Texas, requested the Court to confirm the appointment of John A.Cooper. as Deputy Constable, in and for Precinct No. Ons Titus County, Texas, when Commissioner Old made a motion second by Commissioner Edwards to grant said request and to confirm the appointment, the County Judge put the motion before the members of said court for a vote with the request that as many as favored said motion to vote "Aye" and those oppose to vote "No", Commissioner Zing, Edwards, Old and Fleming all voted "Aye" the County Judge declared motion carried and the order passed,

In the Matter of Appointing
Highway Superintendent, for Titus County, Texas.

On this day came on to be considered by the "commissioner Court, in and for Titus County, Texas, the matter of appointing a Highway Superintendentin and for Titus County, Texas, it appearing to the Court that E.H.Horton, has resigned as such, which resignation is accepted, effected August, 31st, 1922, after considering all applications for the appointment Commissioner Edwards made the following motion, to appoint M.A.Pool, as Highway Superintendent, at a salary of \$85.00 per month, and the remuneration for labor on said highways, be 25 cents per hour, that the County Judge have and exercise full control of said Highway Superintendent, second by Commissioner Eleming, The County Judge put the motion before the members of said court for a vote with the request that as many as favored said motion to vote "Aye" and those oppose to vote "No", Commissioner King, Fleming, Old and Edwards all voted "Aye" the County Judge declared the motion carried and the order passed.

On this the 11th day of September, 1922, came on to be considered by the Commissioners Court of Titus County, Texas, application of J.S.Duncan and seven other freeholders for a public Road, when Commissioner Edwards made a motion second by Commissioner Old, to grant the following racd as a Public Road, Beginning at the Highway at Old Union Church, Thence N.W. to the Ellis Bridge Road, said road being about one male in length, said road is designated as Precinct Road No, 132 and P.D.Bell is appointed overseer. The County Judge put the motion before the members of said court for a vote with the request that as many as favored said motion to vote "Aye" and those oppose to vote "Noy Commissioner King, Fleming, Old and Edwards all voted "Aye" The County Judge declared the motion carried and the order passed.
