Luna, C.T. Lindsay, and J.T. Cameron Commissioners and W.E. McClintock Clerk of Court when the following proceedings were had to-wit

IN THE MATTER OF ALLOWING County Judge E.L. Myers authority to take of all emergency cases,

On this the 12th day of January A.D. 1925, Commissioner Cameron, made a motion to give the County Judge authority to take care of all emergency cases, to give the Clerk authority to issue Warrants in Emergency cases in cases that has to be taken care of in sending Lunatics to the Asylum and other cases such as the County Judge sees best, Motion was seconded by King, the County Judge put the Motion before the court that all favored said Motion to vote AYE all opposed to vote NO, Commissioners King, Luna Lindsay, and Cameron all voted AYE the county judge declared the motion carried and the motion passed.

IN THE MATTER OF APPOINTING PURCHASING AGENT FOR THE COUNTY

On this the 12th day of January A.D. 1925, On Motion by King and second, by Luna, to appoint E.L. Juggie Myers County Judge purchaing agent for the year 1925, the Motion was put before the Court by the County Judge with the request that all favored said motion to vote AYE and all opposed to vote No. Commissioners King, Luna, Lindsay and Cameron all voted Aye None NO, the county Judge, declared the motion carried and the order passed,.

IN THE MATTER OF ALLOWING PAUPERS, FUNDS FOR SUPPORT

On this the 12th day of January A.D. 1925, Commissioner Cameron Made a motion, seconded by King, to allow Ben Graff, the sum of ~~\$5.00~~ \$5.00 and to allow Mollie Smith (col) the sum of \$5.00 to paid out of the General fund, each Month on the 15th of each month, the County Judge presiding there of put the Motion before the court with the request that all favored said motion to vote AYE and all opposed to vote NO. Commissioners, King Luna Cameron and Cameron all voted Aye, the County Judge declared the motion carried and the order passed.

IN THE MATTER OF ALLOWING LEE SANFORD FUNDS

On this the 12th day of January A.D. 1925, Commissioner, Cameron made a motion seconded by Lindsay to allow the said Sanford, fund in the sum of \$10.00 per month to be paid out of the General fund, and to be paid, on the 15th day of each month until further ordered,. The Presiding Judge put the Motion before the court with the request that all favored said motion to vote Aye, and all opposed to vote No. Commissioners King Luna Cameron and Lindsay all voted Aye, the County Judge declared the Motion carried and the order passed.

IN THE MATTER OF APPROVING REPORTS OF OFFICIAL OF THE COUNTY

On this the 12th day of January A.D. 1925, King Made a motion seconded by Cameron to approved reports of R.S. Owens, J.F. Wilkinson, and J.S. Carter and H.J. Green, the county Judge put the order before the court with the request that all favor said motion to vote Aye and all opposed to vote No. Commissioners Lindsay Cameron King and Luna all voted Aye, the County Judge declared the motion carried and the order passed

IN THE Matter of allowing accounts,

On this the 12th day of January AD 1925, Commissioner Cameron made a motion second by King to allow all accounts as listed in Minutes of accounts allowed in Vol 3 Page..... as shown issued of the 13th day of January AD 1925, the presiding Judge put the Motion before the court with the request that all favor said motion to vote AYE and all opposed to vote No. Commissioners Cameron Zing Luna and Lindsay all voted aye the Judge declared the motion carried and the order passed.
