On this the 17th day of February 1925, same on to be considered by a the County Judge of Titus County Texas the petition of D.G.Oliver and nineteen others :: fresholders of the hereinafter subdivision of Titus County Texas; the said signers being: resident fresholders in said subdivision and qualified votors under the constitution and laws of the State of Texas for an order of slection in the limits and confines of said subdivision for the purpose of enabling the freeholders therein to determine whether or not hogs, sheep goate jacks and jennette shall be permitted to run at large therein said subdivision being described by metes and bounds as follows BEGINFIEG at a point on Sulphus Creek the ME corner of the F.E. Greer survey Thunce South with RB line of F.E. Greer survey to North B line of Jno Frather Sur Thence S with RB line of Jon R.Porter sur Thence S with EB line of Somier Sooths Sur to the MS line of M.S.P R RY Sur Thence E to the ME corner of M.E.P and RY Sur: Thence South with MB line of M.E.P and RY Sur Thence South with EB line of Chas Y. White Sur Thence 8 with EB line of T.W. Morris Sur to the MR line of B.B. and C.RY Sur to the ME corner of same Thence S with EB line of B.B. B. and Co RY Sur to White Oak Creek Being the Maple Springs Corner School District

And it appearing to the undereigned Judge of such court that such petition was on the 9th day of February 1925 heard and granted by the Commissioner's Court of Titus County Texas and ordered that such election be held on the 28th day of March . 1985 and that the Judge of said County issue and order therefor and cause, public notice; to be given as required by law.

Now therefore by virtue of the authority vested in me under such order and the law I. E.L. D.C.Oliver and A.V.Flennagin are appointed as managers of said election and election managers being free holders and resident qualified voters of said subdivision they shall appoint their own Clerks they deam necessary to the proper conduct of said elaction He person shall wote at such election galess he is a free holder and also a qualified under the constitution and laws of the State of Texas all votes of such election shall be by ballot the voters desiring to prevent the animals designated herein from running at large shall place upon their ballot the words; "FOR THE STOCK LAR" and those favoring the allowing such animals to run at large AGAINST THE STOCK LAW"

On or before the 10th day after such election the persons holding such alection shall make due returns of all the votes case for and against said proposition to the County Judge of said County who will tabulate and count said returns and ascertain and proclaim the result of said election in the manner prescribed by law.

Public notice of this order shall be given at least 50 days before the date of such election by publication thereof in some newspaper published in eaid county.
