

On this the 14th day of Nov AD 1927 the Commissioners Court of Titus County, Texas, met at the Court House thereof with the following members present to wit: E.L. Myers County Judge presiding C.P. Lindsey Commissioner of Pre. No. 1. Commissioner Luna of Pre No. 2 Commissioner Olde of Pre No. 14. Commissioner King of Pre No. 3, and WE McClintock County Clerk when the following proceedings were had:

IN THE MATTER OF PAYING J.T. LEFTWICH TAX ASSESSOR THE BALANCE DUE HIM FOR ASSESSING 1927 Taxes and after considering the matter and ascertaining that the statutory fee of assessing the County Taxes for said year amounted to \$ _____ and that he has been heretofore advanced the sum of \$ _____ and that there remains due him the sum of \$ _____ Commissioner Luna made a motion seconded by Commissioner Lindsey that the last stated amount be paid to the said Assessor out of the jury fund, the County Judge put the motion before the Court with the request that as many as favored the motion to vote aye and those opposed to vote No, all Commissioners being present and voting in the affirmative the County Judge declared the motion carried and the order passed.

IN THE MATTER OF MORE PARKING AROUND THE COURT HOUSE SQUARE:

On this the 14th day of Nov 1927 came on to be considered by the Commissioners Court of Titus County, Texas, the matters of providing for more convenient parking on the Court House Square and making the square more sanitary and sightly. After considering, the matter and ascertaining that by arranging for more orderly parking that as many vehicles can be parked on a twenty foot space around the edge of the square and that the City of Mt.Pleasant, would bear half the expenses in doing so commissioner Lindsey made a motion seconded by Commissioner King that the City of Mt.Pleasant, be granted the privilege of constructing for providing a parking space on each of the four sides of the square, to be approximately 20 feet wide beginning at the present edge of the Street next to the square on all sides of the square, said 20 foot space to be surfaced with material to be determined by the County Judge working with the mayor of the City of Mt.Pleasant, That the County bear one half of the expense of providing for the above mentioned space and constructing the necessary curbs and gutters, and that the County Judge be given the authority to work, with the mayor of the City of Mt.Pleasant, in working out the details of said work, and letting the contract for said work.

The County Judge put the motion before the Court with the request that as many as favored the motion to vote aye and those opposed to vote NO" all commissioners being present and voting in the affirmative the County Judge declared the motion carried and the order passed.

IN THE MATTER OF FILING SUIT ON DELINQUENT TAXES

The Commissioners Court of Titus County, Texas, met in regular session at the Court house thereof on the 14th day of Nov 1927, with all members present, when came on to be considered the matter of the delinquent and insolvent taxes of the County, After considering the matter and ascertaining that the Amount of delinquent and insolvent Taxes, amount to a good sum and that the County is in of same Commissioner Lindsey made a motion seconded by Commissioner Olde that on and after Dec let, 1927 the County Attorney of Titus County Texas, enter suit against all parties owing either delinquent or insolvent Taxes, The County Judge put the motion before the Court with the request that as many as favored the motion to vote AYE and those opposed to vote NO. All Commissioners

being present and voting in the Affirmative the County Judge declared the motion carried and the order passed.
