

## FOLLOW UP ORDER

THE STATE OF TEXAS  
 COUNTY OF TITUS.....

On the 28th day of March 1928 the Commissioners' Court of Titus County Texas, being in regular session at a regular term of said Court, all members thereof being present, the following proceedings, among others, were had, to-wit:

WHEREAS, heretofore to wit, on the 22nd day of Feb 1928, the Commissioners Court of Titus County passed an order authorizing the issuance of \$30,000 Funding Warrants for the purpose of funding \$30,000 outstanding, Scrip and Warrants against the General Fund of said County for the further purpose of funding warrants issued in payment of valid indebtedness incurred in the construction of improvements purchase of materials, and other expenses incurred under the provisions of the laws of the State of Texas, and the Acts of the Legislature referred to in said order, which order is recorded in Book 4 pages 294- et seq. of the Minutes of said Court,

AND WHEREAS, in pursuance of said order, the following listed original scrip against the General Fund of Titus County has been issued in payment of claims which were duly audited and allowed by the Commissioner's Court of said County prior to the issuance of such scrip, which scrip constitutes valid, subsisting and binding obligations against Titus County, being described as follows, to-wit:

THEREFORE, Be it ordered adjudged and decreed by the Commissioners' Court of Titus County,

Texas:

That said original Warrants, against the General Fund of Titus County, herein listed, be and the same are hereby in all things, adjudicated and held and declared to be valid, subsisting binding and unsatisfied obligations against Titus County, and the acts of the County officers in the issuance of said warrants are hereby in all things ratified and confirmed.

It is further ordered that in conformity with said warrant order, passed on the 22nd day of Feb, AD 1928, Titus County Funding Warrants, to the amount of \$10,000.00 of an issue of \$30,000, of an issue of \$30,000, of the denomination of \$1,000 each, dated March 10, 1928, bearing interest at the rate of 6% per annum, be executed and delivered to the First National Bank of Mt. Pleasant, Texas, the owner and holder of the original Warrants herein listed upon surrender and cancellation of said original warrants.

It is further ordered that E.L. Myers County Judge of Titus County, Texas be and he is hereby authorized and directed to deliver said warrants to the amount of \$10,000 to the First National Bank when the original Warrants herein listed have been surrendered to him and cancelled; said Funding Warrants to be delivered in lieu of and in full satisfaction of said original Warrants.
