On the 3rd day of Aug 1928, the Commissioner's Court of Titus County Texas, was, convened in Special Session at the regular meeting place of said Court, all members thereof being present, when the following proceedings, were had, to-wit:

Whereas, heretofore on the 22nd day of Feb 1928, the Commissioner's Court of Titus County, Texas, passed an order authorizing, the issuance of \$30,000 Funding Warrants for the purpose of funding a like amount of outstanding, scrip and warrants against the General Fund of said County and for the further purpose of funding, warrants issued in payment of valid indebtedness incurred in the construction of improvements and purchase of materials, and other expenses incurred under the provisions of the laws of the State of Texas, and the acts of the Legislature referred to in said order, which order is recorded in Book 4 pages 394 of the Minutes of said County

And Whereas, in pursuance of said order, the following listed original Scrip against the General Fund of Titus County has been issued in payment of claims which were duly audited and allowed by the Commissioner's Court of said County prior to the issuance of such scrip, which scrip constitutes valid, subsisting and binding obligations, against Titus County, being described as follows, to-wit:

That each of said Warrants was drawn in payment of a claim for which the County was legally liable, and for which the County received full value, and the amount of such claims or said warrants, was not in excess of any statutory or constitutional limitation or appropriation, that no litigation or question is threatened or pending affecting said warrants, or any of them, and that the same now constitute valid and binding items of indebtedness against the County of Titus, incurred for proper general purposes and that none of said warrants, were issued for purposes other than permitted by law.

That the Court has received the equivalent in money of the accrued interest on said Funding Warrants 17 to 23 inclusive, from their date to the date of delivery, which amount has been paid to the County by said holders of the original warrants.
