IN THE MATTER OF PAYING J.A. DAVIS FOR INSTALLING HEATING SYSTEM AT THE CO. JAIL

On this the 13th day of Nov AD 1928 when came on to be considered the matter of paying J.A. Davis, for installing a heating system at the County jail, after investigating, the work and the system installed commissioner Lindsay made a motion to pay the agreed price of \$650.00 out of the CH & J fund and that the said Davis be paid with two warrants drawn on said fund one for the sum of \$150.00 and the other for the sum of \$500.00 due and payable Feb 15th 1929, Commissioner Olds seconded said motion and the County judge put the motion before the Court with the request that as many as favored the motion to vote AYE and those opposed to vote NO all Commissioners present and voting in the affirmative the County judge declared the motion carried and the order passed.

IN THE MATTER OF MAKING A LOAN FROM THE JURY FUND TO THE RAB FUND.

On this the 13th day of Nov AD 1928 came to be considered by the Commissioners Court of Titus County Texas, in the matter of making a loan from the Jury fund to the RAB fund when came commissioner King made a motion that that \$750.00 be borrowed from the jury fund for the
