Authorizing, the issuance of \$30,000 Titus County Funding Warrants.

WHEREAS, on the 22nd day of Feb 1928, the Commissioners Court of Titus County passed an order authorizing the issuance of \$30,000 of General Funding Warrants, as is more fully set forth in the order of said Court duly of record in the minutes thereof; and

Whereas, in said order provision was made for retiring certain interest bearing time warrants theretofore issued by the County said warrants, being more fully described as follows: to wit: (a) \$8,000 Titus County Funding Warrants, dated March 10, 1923, bearing interest at the rate of 6% per annum and maturing, \$4,000 on April 10th of each of the years 1928 and 1929, (B) \$3,000 Titus County Funding Warrants, dated May 10th 1923, bearing interest, at the rate of 6% per annum and maturing in 1930,

and Whereas, of the Warrants described in paragraph (a) Supre, the \$4,000 of said Warrants maturing in 1928 have been already retired; and

Whereas, adequate provision has been made in another order passed by the Court on this date to provide for the remaining \$4,000 of said issue and to provide for the \$3,000 of interest bearing time warrants described in paragraph (b) supre and

Whereas, the County has outstanding certain General Funding Scrip in the approximate amount of \$6,000 to be described in a follow up order to be passed on this date; and

Whereas, The County has under consideration the issuance of additional Scrip during the Current year in the amount of approximately \$1,000 which might be included in said original funding order, and

Whereas, it is considered to be to the best interest of the County to include in the original funding, warrant order the scrip in the amount of \$7,000 described herein, in lieu of the \$7,000 of interest bearing time warrants:

BE IT ORDERED BY THE COMMISSIONERS: Court of Titus County, Texas, 1. That said original funding warrant order passed Feb 22nd 1928, be amended on the first page thereof in reference to the bearing description of interest/time, warrants, by striking out the two paragraphs describing the \$11,00 of interest bearing time, warrants, and by substituting, in lieu thereof the following:
 (a) Titus County Funding Warrants, dated March 10, 1923 bearing interest at the rate of 6% per annum, maturing \$4,000 April 10, 1928; (b) \$7,000 of Scrip lawfully issued against the General Fund of the County \$6,000 of which shall be issued prior to and including, Dec 10, 1928 and \$1,000 of which to be issued thereafter, all of which \$7,000 of Scrip to be specifically described in follow up orders, authorizing, their exchange for funding warrants, Passed and approved, this the 10th day of Dec 1928.

WHEREAS, there are outstanding, against the General Fund of the County certain interest bearing time warrants which mature at such times and in such accounts as to unduly burden the taxing power of the County, but which if refunded into warrants having longer maturities would not embarrass the County, which said time warrants are described as follows, to wit:

(a) Titus County Funding Warrants, dated March 10, 1923, bearing 6% interest, originally issued in the amount of \$_____ now outstanding in the amount of \$4,000 - which \$4,000 of warrants mature April 10, 1929;

(b) Titus County Funding Warrants, dated May 10, 1923, bearing 6% interest, originally issued in the amount of \$15,000, maturing \$3,000 in each of the years 1930 to 1934, inclusive now outstanding, in the amount of \$15,000. (c) Titus County Funding Warrants, dated Jan _____ 1921 bearing 7% interest originally issued in the amount of \$_____ now outstanding, in the amount of \$6,500.00 maturing \$3,500 in 1929 and \$3,000 in 1930, Total interest bearing time warrants included in the present, funding issue, \$25,500.00

And Whereas, Certain Scrip will be issued against the General Fund before taxes, for the current year are available to pay same, and there is under consideration the advisability and necessity of levying a tax to insure the legality of such scrip and for extending the time of payment of said scrip, and in consideration thereof, issuing, to the holder in lieu thereof interest bearing time, warrants, which said scrip will be in the aggregate amount of \$340.00, late to be described in follow up orders and Whereas, the time warrants heretofore issued and now outstanding were originally issued to take up scrip, and Whereas, in each instance where the item of scrip was in excess of Five Hundred Dollars, (\$500.00) and less than Two Thousand Dollars (\$2,000) the contract furnishing the basis of said expenditure was first submitted to competitive bids, and said contract was awarded upon competitive bids at a regular term of Court except in those instances where said warrants represented expenditures for work done under the immediate supervision of the Commissioner's Court and paid for by the day, thus issued in compliance with Articles 2368, et seq. Revised Statutes of 1925, and in those instances where the items were for more than five hundred Dollars, \$500.00 and where there were no competitive bids as described above, said warrants represent the indebtedness for several distinct transactions or contracts, the amount of no single item or contract being in excess of Five Hundred Dollars (\$500.00) and

Whereas, it is considered that approximately, but not exceeding Three Hundred Forty Dollars (\$340.00) scrip will be issued against said fund during the current year and provisions must be made at this time for said total issue, but delivery of said funding warrants to be made only, if, as and when original scrip of an equal amount is surrendered to the County by the holder for cancellation, said surrender and cancellation to be evidenced by proper resolutions, to be passed by the Court identifying the original time warrants, scrip and the funding warrants and proper certificates executed by the County Judge, County Clerk and County Treasurer, and

Whereas, the County can meet the payments of principal and interest as provided in this issue of warrants without embarrassing the administration of ordinary County affairs, by reason of the impounded tax provided herein;

Therefore, be it ordered by the Commissioner's Court of Titus County, Texas:

1. That Warrants of said County, to be denominated Titus County Funding Warrants, Series 1928 a" be issued under and by virtue of the Constitution and laws of the State of Texas, for the purpose of funding and refunding, an equal amount of interest bearing time warrants and scrip of said County theretofore duly and legally issued for General Expenses, purposes and which at delivery and which at delivery of said funding warrants are and shall be valid, subsisting and outstanding obligations against the General Fund of said County the claims for which shall have been audited, approved and allowed by the Commissioner's Court prior to the issuance of said warrants and which are to be surrendered and cancelled and the Funding Warrants, Series 1928 a hereby authorized issued to the holder in lieu thereof:

2. Said warrants shall be numbered consecutively from one (1) to Twenty Six (26) inclusive and shall be in the denomination of One Thousand Dollars (\$1,000) each, except No. 1 for Eight Hundred Forty (\$840.00) Dollars aggregating Twenty Five Thousand Eight Hundred Forty Dollars, \$25,840.00) They shall be dated Dec 15th 1928 and shall mature serially as follows:

Said Warrant shall bear interest at the rate of Six per cent (6%) per annum from date thereof until fully paid interest payable April 10, 1929, and semi annually thereafter on April 10th and Oct 10th of each year, which interest shall be evidenced by Coupons, attached to each of said Warrants. The principal and interest of said Warrants, shall be payable upon presentation and surrender of warrants of proper coupons at Guaranty Trust Co. of New York New York, N.Y.

4. Said Warrants shall be signed by the County Judge attested by the County Clerk and registered by the County Treasurer and the seal of the Commissioners Court shall be impressed upon each of them; the facsimile signatures of the County Judge and the County Clerk may be lithographed upon the interest coupons.

7. It is further ordered by the Court that said original time warrants outstanding against the General Fund of said County intended to be taken up by the Funding Issue, be and the same are hereby in all things validated and held and declared to be valid subsisting, binding and unsatisfied obligations, against said County and against the General Fund of the County, and the acts of the County officials in the issuance of said Warrants are hereby in all things ratified and confirmed.

8. Wherever the holder of the warrants and scrip to be substituted by and exchanged for said Funding Warrants shall notify the County Judge that he has assembled as much as Three Thousand Dollars (\$3,000) of the County's Warrants, or Scrip eligible for funding it shall be the duty of the Court to pass a proper order and it shall be the duty of the County officers to execute proper certificates perfecting such exchange. Said orders shall from time to time identify the warrants or scrip refunded as well as the funding warrants delivered.

It is further ordered, adjudged and decreed by the Commissioner's Court of Titus County, Texas, that a special fund, to be designated Funding Warrant Fund, Series 1928-a shall be created and is hereby created, and the proceeds of all taxes collected for or on account of this series of Warrants shall be credited to said fund for the purpose of paying the interest on and providing a sinking fund for the redemption of said warrants at maturity, and to provide for ten per cent (10%) attorney's fees in case of default, and said fund shall be used for no other purpose; that to create said fund a tax of six cents (6c) on the One Hundred Dollars valuation of taxable property in Titus County is hereby levied for the current year 1929, out of the constitutional twenty five cents (25c) General Fund Tax of the County that for the year 1930 and for each thereafter while any of said warrants or interest are unpaid, and at the time other county taxes are levied during the said year, there shall be computed and ascertained what rate of tax based upon the interest approved tax rolls of said County will be necessary, requisite and sufficient to fully make, raise and produce in each of said years the amount of interest and principal to be paid in that year, and to provide ten per cent 10% attorney's fees in case of default for each of said years there is hereby ordered to be levied a tax at such rates as shall be necessary as aforesaid, and that such taxes, when collected shall be appropriated and applied to the purposes named.

To pay the interest maturing on said issue of warrants, respectively on April 10, 1929, and Oct 10 1929, the sum of \$1450.00 is hereby apportioned out of Funds available in the General Fund of the County. The County Judge and County Clerk are hereby ordered and directed to draw a warrant on the County Treasurer for said sum of Money and the Treasurer, is ordered and directed to cash said warrant and to hold and proceed available for the purpose of paying said interest and for no other purpose. Any excess remaining of said sum after paying said interest, shall revert to the interest and sinking fund of this warrant issue.
