BE IT REMEMBERED That the Honorable Commissioners Court of Titus County, meet on the 25th day of Dec AD 1933 at the Court House in the town of Mount Pleasant, Texas, in pursuance to a special call meeting by the County Judge, with the following present to wit; The Honorable A.K.Luna judge Presiding, and Commissioners R.W.Blankenship, R.L.Thomas, L.H.Wilson, and A.S.Lilly, when the following business and matters pertaining thereto were had to wit;

That Thereas, the Commissioners did in the manner, form and time required by laws of The State of Texas, did submit and adopt a budget as required by Article, 689a- 9-10-11-12 of the Revised Statue of Texas, and which is now on file with the County Clerk of Titus Co., Texas, as well as a copy with the Comptroller of The State of Texas, and being for the year 1935-4. and

Whereas, since the adoption of said budget aforesaid and filing of same for the year 1933-19.4, there now and has existed since the adoption of said budget aforesaid an emergency expenditure of money, of a grave public necessity to meet an unusual and unforeseen condition, which by the exercise of reasonable diligent thought and attention could not have been included in the original budget aforesaid; in that said original budget did not carry any appropriation for the expenditure of purchasing of right of way and

Whereas, since the adoption of said budget aforesaid, the president of the United States in order to help and render aid to the jobless and unemployment, did under the powers given him by Congress, and the Federal Government did appropriate certain sums of money for the construction of Highways in Texas, and

Whereas, the State Highway Commission did request the said County of Titus to secure right of way and road beds for the re-location, widening, straightening and lengthening State Highway Number One, and State Highway Number 49, in Titue County, Texas, which request was made bysaid Commission subsequent to the adoption of the present budget of Titus County, Texas, and

Whereas, the Commissioners Court could not by the exercise of reasonable diligent thought and attention foreseen said request for this expenditure of money, and

Whereas in compliance to said request of said State Highway Commission to secure such right of way its has become necessary to buy and purchase from the land owners owning such right of way as well as to institute condemnation proceedings to obtain such needed right of way for the above mentioned purposes, all of which will incur the expenditure of \$5000.00 from the Road and Bridge Fund of Titus County, Texas and

The Court after hearing argument upon the proposition of amending the budget aforesaid to meet the situation, a motion was made by A.S.Lilly Commissioner of pre Number 4 and seconded by Commissioner R.W.Blankenehip, Commissioner of Pre No 1 that the original budget of Titus County, Texas, as it now stands for year, 1933-1934 be amended, so amending said budget that it shall provide for the expenditure of the sum of \$5000.00 which sum is necessary for the purchase and condemnation of the new proposed right of way on State Highway Cne and Number 49, in Titus County Texas as per the map and plan furnished to Titus Co.Tex by State Highway Commission of Texas and

the motion was placed before the Commissioners By the County judge with a request that all

that were in favor of said motion to vote Aye and those opposed vote Now and Commissioners, Blankenship, Thomas, Wilson and Lilly Voted AYE and the County Judge declared said Motion carried and adopted.

So it is the order and judgment of the Commissioners Court that the original County Budget...
for TitusCounty, Texas as prepared and required by law aforesaid for year 1933-54 is herewith
amended, and so amended that said Budget provides for the expenditure of the sum of \$5000.00
to be drawn out of the Road and Bridge fund, upon warrants issued by the proper officers
for the expenditures of securing the said right of way on said State Highway Number one and State
Highway Number forty Nins.

And that a copy of this order amending the original budget as aforesaid be filed with the Clerk of the County Court, end attached to the budgett originally adopted for year 1953-1954 as
