Motion was made by County Commissioner Brown and seconded by County Commissioner Lunsford to approve the monthly report of J. W. Edwards, J. P. The motion carried unanimously.

Motion was made by County Commissioner Cody and seconded by County Commissioner Stringfellow to approve the monthly report of J. W. Spruill, J. P. The motion carried unanimously.

Motion was made by County Commissioner Lunsford and seconded by County Commissioner Stringfellow to approve the monthly report of Loyd Graf, Constable. The motion carried unanimously.

Motion was made by County Commissioner Lunsford and seconded by County Commissioner Stringfellow that the monthly report and expense account of A. B. Gilpin, County Clerk, be approved. The motion carried unanimously.

Motion was made by County Commissioner Brown and seconded by County Commissioner Cody to approve the monthly report and expense account of G. R. Ard, Sheriff. The motion carried unanimously.

Motion was made by County Commissioner Stringfellow and seconded by County Commissioner Lunsford to approve the monthly report and expense account of Morris Rolston, County Attorney. The motion carried unanimously.

Motion was made by County Commissioner Cody and seconded by County Commissioner Brown that the monthly report and expense account of Aubrey Redfearn, be approved. The motion carried unanimously.

County Commissioner Lunsford made a motion, seconded by County Commissioner Brown, that the ex-officio salary of Jessie Johnson be raised from \$50.00 per month to \$60.00 per month. The motion carried unanimously.
