12th day of November A. D. 1937, at the Court House of Titus County, Texas, with the following members present, to wit: C. T. Nsugent, County Judge, and County Commissioners Stringfellow and Lunsford. When came on to be considered by the court the purchase of School House Bonds of

Common School District Number 19 of Titus County, Texas. When County Commissioner offered the following order to said court and made a motion that the same by passed by the court, which motion was seconded by County Commissioner Stringfellow. The order in word and figures is as follows; to wit:

It appears to the Commissioners Gourt of Titus County, Texas, that the Bonds of Common School District Number 19 of Titus County, Texas, numbered 1 to 17 of date July 20th 1937 1937, in denominations of \$140.00 each, bearing interest at the rate of 5% from date are offered to this court for par and accrued interest as an investment for the permanent school fund for Titus County, Texas, and that the same should be purchased for said purpose.

It is, therefore, ordered, adjudged and decreed by the Commissioners Court of Titus County, Texas, that Bonds Numbers 1 to 17, both inclusive of Common School Dietrict No. 19 of Titus County, Texas, dated July 20th, 1957, bearing interest at 5% per annum from date be and the same are now purchased at par and accrued interest, in the aggregate amount of \$2417.01, as an investment for the permanent school fund for Titus County, Texas and that the Clerk of this court is sue warrant against the permanent school fund for said amount is settlement of such purchase.

The County judge put the same motion and order to the Commissioners Court of Titus County, Texas, with the request that as many as favored the motion and order would vote "AYE" and all those opposed to vote "NO". County Commissioners Stringfellow, Lunsford and County Judge Neugent voted "AYE". none voted "NO". the County Judge declared the motion carried and the order, passed.

The foregoing minuts of the Commissioners Court of Titus County, Texas, read and in all things approved this the 12rh. day of November A. D. 1937.

WHEREAS, after making an investigation into the competency, experience and ability of W. B. Wright, of the Wright Abstract Co., of Mt. Pleasant, Texas, as to his fitness for

said work, and after considering the same, are of the opinion that he is a proper party to make and install such a Plat System; and that he has no official connection with any sounty office within earld county, and that he is not related by affinity or consanguinity to any member of the Commissioners' Court now holding office in earld county:

Now, therefore: This Contract made and entered into by and between the County of Titus, a body Politic and Corporate, acting herein by and through its Commissioner's Court, joined by the Comptroller of Public Accounts of the State of Texas, hereinafter styled First Party, and W. B. Wright, of the Wright Abstract Co., of the County of Titus, state of Texas, hereinafter styled second Party:

WITNESSETH:

First party agrees to employ and does hereby employ second party to make and install a complete plat book system or block map for Titus County, Texas, showing each and every tract, lot or parcel of land in Titus County, Texas, with description thereof, said plat book to have each and every tract, lot or parcel of land numbered, and to show the contents in each and every tract, lot or parcel of land and the record owner of each as of January 1st 1938.

Second party agrees to perform the above mentioned service for First Party, and to do same in a skillful manner, for and in consideration of the payments hereinafter mentioned; that Second Party will employ all necessary skilled help on said work and obligate himself to furnish all labor of whatsoever kind or character necessary and, at his own expense to make said plat of Titus County, Texas, showing each and every tract, lot or parcel of land situated therein, showing same properly numbered, and showing the number of acres in each and every tract, lot or parcel of land and the record owner of same as of January let 1938; and second party agrees to pay for and furnish all material necessary in the making and binding of said Plat Books.

For the services hereinabove mentioned, first party agrees to pay second party, in cash, an amount equal to Fifteen per cent (15%) of all delinquent Taxes collected, to be computed on all Taxes delinquent on July 1, 1937, until the sum of Four Thousand Nine Hundred (\$4,900.00) Dollars is paid to second party. Said payments to be made in accordance with law, and under direction of Commissioner's Court on sworn statements of second party, as the work progresses.

First party is authorized to retain twenty-five (25%) per cent of said amount of \$4,900.00 until said Plat Book is completed and accepted by the Commissioner's Court of Titus County, Texas.

Second Party obligates and binds himself to begin said work at once and to complete the preparation and installation of said plat book system on or before January 1st 1939.
