IN THE MATTER OF CALLING A NEW BEER ELECTION:

In obedience to an Order of the District Judge, the Court took up the matter of calling a new election to decide whether or not the sale of beer in Titus County would be prohibited. Motion was made by County Commissioner and seconded by County Commissioner Stringfellow that the Beer Election be set for March 5, 1938. Upon a vote of the Commissioners' Court, and all members having voted "ays", the Beer Election was set down for March 5, 1938. The Order of the District Court and formal order of the Commissioners' Court cetting the election, are as follows:

JUDGMENT

On this day this cause was celled for trial when came the Contestants and Contestes in person and by their respective attorneys, and all parties announced ready for trial and, this being a contest of the local option Beer election held in Titus County on December 11, 1937, the matters of fact as well as of law were submitted to the Court who, after hearing all pleadings of the parties and all evidence submitted and after hearing full and complete arguments of all parties on the law and facts, the said cause was taken by the Court under advisement and after due examination and careful consideration of all the evidence and the law and being of

the opinion that the law and facts are with the Contestants, did on the 31st day of January 1938 render and enter his judgment in said same.

It is therefore ordered, adjudged and decreed by the Court, upon consideration of all questions relating to the legality and validity of said election, as shown by the pleadings and evidence, that on account of such irregularities on the part of those intrusted with the control of the conduct and management of the local option election held in Titus County, Texas on December 11, 1937 and on account of the number of voters who voted illegally in said election and the number of illegal' ballots counted by the managing officers of said election, it appears to the Court from the evidence that such irregularities existed in the holding of said election as to render the true result of said election very doubtful of ascertaining; and that it is the judgment of the court that said election is void.

It is therefore further ordered, adjudged and decreed by the court that the said local option election held in Titus County on December 11, 1937 be and the same is hereby in all things declared void and of no legal force and effect.

It is further ordered, adjudged and decreed by the Court that the County Judge and County Commissioners of Titus County, composing the County Commissioners' Court of said county, be and they are hereby ordered and commanded to order another election to be held in Titus County, Texas according to law, in order that the qualified voters of said county may determine at said election whether or not the sale of beer containing not exceeding four (4%) per centum of alcohol by weight shall be prohibited in said County.

It is further ordered, adjudged and decreed by the Court that the Clark of this court immediately upon adjournment of this term of court make a true copy of this judgment and certify to the same under his official seal and signature and deliver the same to the Commissioners' Court of Titus County, Texas for observance.

It is further ordered, adjudged and decreed by the court that the officers of this court do have and recover of and from Contestants all their ocets in this behalf caused to accrue by the said Contestants, but that no costs be adjudged against the Contestee, for all of which let execution issue.

THEREFORE, BE IT ORDERED, ORDAINED AND DECREED by the County Commissioners' Gourt of Titus County, Texas that an election be held throughout the entire county of Titus at each places in each and all of the voting precinct thereof under the General Election Laws and the said lique control Act, in order that the qualified voters of said Titus County, at eaid election, may determine whether or not the sale of beer containing not exceeding four (4%) per centum of allochol by weight shall be prohibited in Titus County.

IT IS HEREST ORDERED, ORDAINED AND DECREED that said election shall be held on the 5th day of March, A.D. 1938, at each and all the voting precincts in Titus County and said election shall be held and governed by the rules of law governing Ceneral Elections, as provided by Section 36 of the Acts of 1935, 2nd called session, page 1795, art. 565-36, Penal Code Vernon's Annotated Statutes. The said election shall be held upon an official ballot as follows:

OFFICIAL BALLOT

"FOR prohibiting the sale of beer containing alcohol not exceeding four (4%) per centum by weight.

"AGAINST prohibiting the sale of beer containing alcohol not exceeding four (4%) per centum by weight."

IT IS FURTHER ORDERED, ORDAINED AND DECREED by the Court that a true copy of this order, duly certified to by the Clerk of this Court, be posted one place in each election precinct in Titus County, Texas for at least six (6) days prior to the date of the election.
