WHEREAS, all of the above mentioned script warrants were and are valid obligations upon the Road and Bridge Fund of said County; and there may not be sufficient funds on hand in said Road and Bridge Fund to pay said warrants when presented, and The First National Bank in Mt. Pleasant, Texas, being the depository for said County, has had and will in due course have such script warrants presented to it for payment; and

WHEREAS, it is contemplated that said County will receive about the month of April, 1939, prior thereto and thereafter, certain funds and monies as its part or portion due for automobile licenses and registrations in said County for said year, and it will become a part of the Road and Bridge Fund of said County.

NOW, THEREFORE, be, and it is, hereby ordered by the Commissioners Court of Titus County, Texas, that there be and is hereby pledged unto The First National Bank in Mt. Pleasant, Texas, its successors and assigns, the first monies and revenues due and owing and that may be paid and collected as the County's part or portion of the automobile licenses and/or registrations for and on automobiles or other motor vehicles paid in said County for the year 1939 from and with which to re-pay said Bank for the amounts of the above mentioned script warrants, with interest as herein provided, which said Bank has paid, or may hereafter pay, to the holders thereof; and said Commissioners Court hereby obligates said County to pay unto the said The First National Bank in Mt. Pleasant, Texas, its successors and assigns, the amount of its aforesaid script warrants obligations which said Bank has paid or may hereafter pay unto the holders thereof, together with interest upon each of said warrants from the date of the paying of same by said Bank to the holders thereof at the rate of 6% per annum.

AN ORDER

CREATING ROAD DISTRICT NO. THREE OF TITUS COUNTY, TEXAS.

WHEREAS, it appears to the Court that certain territory within Titus County should be created and established into a road district pursuant to the provisions of Article 3, Section 52, of the Constitution of the State of Texas, and pursuant to Chapter 16, Acts of the First Called Session of the 39th Legislature; and,

WHEREAS, the fractional portion hereinafter described does not contain any territory of a road district heretofore created within said county and contains no fractional portion of any previously created district which has issued bonds:

BE IT ORDERED, ADJUDGED AND DECREED BY THE COMMISSIONERS' COURT OF TITUS COUNTY,

TEXAS:

1. That the following described territory is hereby established and created into Road District No. Three of Titus County, Texas, and shall hereafter have all of the rights and powers conferred on road districts created under the provisions of Section 52, Article 3, of the Constitution and laws passed pursuant thereto, the territory thus included in said road district being described as follows, to-wit:

BEGINNING at the N. E. corner of Titus County, Texas; THENCE in a Westerly direction along the North Boundary line of the County to the Northwest corner of the County; THENCE in a

Southerly direction along the West Boundary line of Titus County to the intersection of the West Boundary line of the County and White Oak Creek; THENCE in a Southeasterly direction with the meanders of White Oak Creek to the East Boundary line of Titus County; THENCE in a Northerly direction along the East Boundary line of the County to the Northeast corner of Titus County and the PLACE OF BEGINNING.

All orders or parts of orders in conflict herewith are hereby expressly repealed insofar as they conflict herewith.

TO THE RESIDENT PROPERTY TAX PAYING VOTERS IN ROAD DISTRICT NO. three OF TITUS COUNTY, TEXAS:

TAKE NOTICE THAT A Hearing will be had at the Court House in the City of Mt. Pleasant on a petition to the Commissioners' Court on the proposition of issuing the bonds of said Road District in the amount of Two Hundred Thousand (\$200,000.00) as more particularly

set out in the order fixing the hearing as follows:

AN ORDER

FIXING DATE FOR HEARING ON THE PETITION FOR THE
ISSUANCE OF BONDS BY ROAD DISTRICT NO. THREE

WHEREAS, there came on to be considered the petition of W. W. Blalock and 149 other persons praying the Court to order an election to determine:

"Whether or not the bonds of Road District No. Three shall be issued in the amount of Two Hundred thousand (\$200,000.00) Dollars, bearing interest at the rate of not to exceed five and one-half (5½%) per cent per annum, payable semi-annually and maturing at such times as may be fixed by the Commissioners' Court, serially or otherwise, in not to exceed thirty (30) years from the date thereof, for the purpose of the construction, maintenance, and operation of macadamized, graveled or paved roads and turnpikes, or in aid thereof, throughout Road District No. three, and whether or not an ad valorem tax shall be levied on all taxable property in said Road District No. three sufficient to pay the annual interest and to provide a sinking fund sufficient to redeem said bonds at their maturity."

; and

WHEREAS, it appears to the Court and is so adjudged that said petition is signed by at least fifty (50) of the resident property tax paying voters residing in said District; and

WHEREAS, said Road District has heretofore been legally created by the Commissioners' Court by order duly entered on the 10th day of Oct., 1938, which order is of record in the Minutes of the Commissioners' Court, Volume 5, Page 351, et seq;

BE IT ORDERED BY THE COMMISSIONERS' COURT OF TITUS COUNTY, TEXAS:

1. That a hearing shall be had by this Court at the Court House in the City of Mt. Pleasant on said petition on the 28th day of Oct., 1938, which date is not less than fifteen days (15) nor more than thirty (30) days from the date of this order;
2. The Clerk of this Court shall forthwith issue a notice of the time and place of hearing, which notice shall inform all persons concerned of the time and place of hearing and of their right to appear at such hearing and contend for or protest the ordering of such bond election;
3. Such notice shall state the amount of the bonds proposed to be issued, and shall describe the road district by its number, and shall describe the boundaries thereof as contained in the order establishing the district;
4. The Clerk shall execute said notice, posting true copies in three public places within said road district and one at the Court House door of the County. Said notice shall be posted for at least ten (10) days prior to the date of said hearing. Said notice shall also be published in a newspaper of general circulation in the subdivision or district, if a newspaper is published therein, one time, and at least five days prior to such hearing. If no newspaper is published in such district, then such notice shall be published in some newspaper in the County if there be one; the duties herein imposed on the Clerk may be performed by the Clerk in person, or by the deputy;
5. Said hearing shall be conducted under the provisions of Chapter 16, Acts of the First Called Session of the 39th Legislature; and pertinent amendments thereto;
6. The metes and bounds of Road District No. Three as created by Commissioners' Court on the 10 day of Oct., 1938, are as follows, to-wit:

BEGINNING at the N. E. corner of Titus County, Texas; THENCE in a Westerly direction along the North Boundary line of the County to the Northwest corner of the County; THENCE in a

Southerly direction along the West Boundary line of Titus County to the intersection of the West Boundary line of the County and White Oak Creek; THENCE in a Southeasterly direction with the meanders of White Oak Creek to the East Boundary line of Titus County; THENCE in a Northerly direction along the East Boundary line of the County to the Northeast corner of Titus County and the PLACE OF BEGINNING.
