ORDER FOR COURT HOUSE BOND ELECTION

THE STATE OF TEXAS

On this 14th day of March, 1939, the Commissioners' Court of Titus County, Texas, convened in regular session at a regular term of said court at the regular meeting place in the courthouse at Mt. Pleasant, with all the members thereof present, viz:

and passed the following order:

IT APPEARING AFFIRMATIVELY to the Court that Titus County is in need of a courthouse, and that it will be to the best interest of Titus County and its citizens and taxpayers to erect a courthouse for said County and to make provision for payment thereof by
the issuance of bonds for that purpose, provided such bonds shall be authorized by a majority
vote of the property taxpaying voters of said County, at an election to be held for that
purpose, as hereinafter more fully set out in this order;

TT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Commissioners' Court of Titus County, Texas, that an election be held in and throughout said Titus County, Texas, on the let day of April, 1939, which is not less than 15 nor more than 30 days from the date of this order, to determine whether or not the bonds of said Titus County, Texas, shall be issued in the amount of \$160,000.00, bearing interest at the rate of \$45 per amoun, and maturing estally within 15 years from their date, as may be determined by the Commissioners' Court of said County, for the purpose of erecting a County Courthouse for Said Titus County, and whether or not ad valorem taxes shall be levied upon all taxable property in said County for the purpose of paying the interest on such bonds and to create a sinking fund for the redemption thereof at maturity, as authorized by the Constitution and laws of the State of Texas, and particularly Chapters 1 and 2 of Title 28, Revised Civil Statutes of Texas and mendments thereto.

Said election shall be held under the provisions of Chapters 1 and 2 of Title 22 Revised Givil Statutes of 1925 and emendments thereto, and the manner of holding such an election and making and canvascing returns thereof shall be governed by the general laws of the State of Texas when not in conflict with the hereinbefore mentioned Statutes.

Only duly qualified electors who own taxable property in said fitus County, Taxas, and who have duly rendered the same for taxation shall be qualified to vote at said election, and all electors shall vote in the election precinct of their residence.

All voters who favor the proposition to issue such bonds and levy ad valorem taxes in payment thereof shall have written or printed on their ballots the words "FOR THE ISSUANCE OF BONDS"; and those opposed thereto shall have written or printed on their ballots the words "AGAINST THE ISSUANCE OF BONDS".

Such election shall be held at the regular voting places in all the election precincts in Titus County, as hereinafter set out, and such voting places and the election officers therefor are and shall be respectively as follows, to-wit:

notice on the same week day in each of two successive weeks in some newspaper of general circulation published within said County, the date of the first publication to be not less than 14 days before the date of said election and in addition thereto by posting such notice in each of the election precincte of said County and one at the County courthouse of said County at least 14 days before the date of said election and the County Clerk is hereby directed to prepare such notices and the Sheriff is likewise directed to post the same and to make return on a copy of such notice showing how and when he posted them; and further orders are reserved until such election shall have been held and returns thereof made to this Court.
