BE IT REMEMBERED that the Commissioners' Court of Titus County, Texas, met in Regular Session on the 8th day of July, 1940, with the following members present, to-wit:

IN THE MATTER OF APPROVING MONTHLY REPORTS AND EXPENSE ACCOUNTS: (for JUNE, 1940)

Motion was made by Commissioner Lunsford and seconded by Commissioner Brown to approve monthly expense account of Aubrey Redfearn, Constable. All voted "aye" and the motion carried unanimously.

Motion was made by Commissioner Lunsford and seconded by Commissioner Brown to approve the monthly expense account of A. B. Gilpin, County Clerk. All voted "aye" and the motion carried unanimously.

Motion was made by Commissioner Lunsford and seconded by Commissioner Brown to approve the monthly expense account of G. R. Ard, Sheriff. All voted "aye" and the motion carried unanimously.

Motion was made by Commissioner Lunsford and seconded by Commissioner Brown to approve the monthly expense account of P. O. Wilhite, Tax Assessor & Collector. All voted "aye" and the motion carried unanimously.

IN THE MATTER OF GRANTING PETITION FOR NEW ROAD:

Motion was made by Commissioner Lunsford and seconded by Commissioner Garrett to grant a new road as per petition attached. All voted "aye" and the motion carried unanimously.

TO THE HONORABLE COMMISSIONERS' COURT OF TITUS COUNTY, TEXAS IN
TO ALL PERSONS LIVING ON AND NEAR THE FOLLOWING DESCRIBED PUBLIC ROAD.

We, the undersigned freeholders of Commissioner's Precinct No. 1, Titus County, Texas, hereby give notice to all persons and property owners in said precinct, that we are going to file a petition with the Commissioners' Court of Titus County, Texas, to have the following described road designated as a First Class public road, after having written advertisement of this application posted at three public places, to-wit: One at the Courthouse door in the City of Mt. Pleasant, and other two notices at public places in the vicinity of said road and that said notices shall be posted at least twenty days prior to a hearing hereon by the Commissioners' Court

of Titus County, Texas. Said proposed road is described as follows, to-wit:

Being approximately four miles Northwest from the City of Mt. Pleasant, Texas; BEGINNING, close to the Damascus Church and starting at Moore's West boundary line and Will Hinson's East boundary line; THENCE North to the Damascus Church; THENCE North across Jack Spezman place or farm across the old Paris Road at Colley's store; THENCE North across Rogers estate Land on West boundary line and Johnny Leftwich East boundary line through Elmer Sackett farm; THENCE still North through Earl Lide place; thence through Alf Bridges place; Thence through old Hinton place and through Stacy Newman place up to his house; THENCE East through Newman place down to the New Highway 49, being the Talco-Mt. Pleasant New Highway now under construction.

Hearing on said application will be heard by the Commissioners' Court of Titus County, Texas, in the office of the County Judge, in the City of Mt. Pleasant, Texas, and anyone interested in said route or wishing to show why said road should not be designated as a public road may appear and contest said application, said hearing being at 10 o'clock A. M. on the 8th day of July, 1940.
