IN THE MATTER OF APPOINTING A. J. GAUTNEY REPAIRMAN FOR COURT HOUSE & JAIL FOR 1943.

Motion was made by Commissioner Goodwin seconded by Commissioner Nugent to appoint A. J. Geutnsy se repairman for Courthouse & Jail at a salary of \$100.00 to be paid out of the Fermanent improvement Available fund. Fortion was put before the Court by the County Judge and all members voted "Aye".

IN THE MATTER OF KEEPING COUNTY AND PRECINCT OFFICERS ON FEE BASES FOR 1943:

Motion was made by Commissioner Goodwin end seconded by Commissioner Nugent to compensate ell county end precinct officers, exclusive of Registrars of Vital Statistics, County Surveyors, Noteries Public, by fees earned by them in the official duties.

The following order was peesed.

"Un this the 11th. day of January, 1943, come on to be considered the matter of keeping County and Precinct Officers on a fee basis, or on a salary. It appearing to the Commissioners' Court that the population of Titus County, according to the last Federal Census, is under twenty thousand, and that it be to the best interest of the County to remain on the fee system for the year 1943, Commissioner Goodwin made a motion that the Court adopt an order to that effect.

The motion was seconded by Commissioner Nugent. The County Judge put the motion before the Court, and all members voting "Aye", the motion carried unanimously, and the order was passed.
