"On the 20 day of April A.D.1944 came on to be heard and considered by the Commissioners' Court of Titus County, Texas, all members of said Court being present, the application of Humble Oil * Refining Company for right of way and sasament privileges for the purposes of constructing, maintaining and operating pipe lines under and across the public roads and highways in Titus County, Texas, and also under and across all streets and alleys in any unincorporated town in said County, for the purpose of transporting petroleum oil, gas, water, or other solutions; and the said application having been duly considered by this Court, and this Court being of the opinion the same should be granted, it is ordered by the Court, so adjudged and decreed, that the said right of way and easement privileges for the above purposes, whether such pipe lines have been heretofors or may be hereafter constructed, be granted to the maid Humbls Oil & Refining Company, its successors and assigns, upon the following texas and conditions, to-wit:
