IN THE MATTER OF APPROVING MONTH ACCOUNTS.

Motion by Commissioner Banks seconded by Commissioner Nugent to approve the monthly accounts as recorded in Volume 7 Minutes of accounts allowed, all members voted "aye" motion carried unanimously.

Motion by commissioner Taylor seconded by Comm. Goodwin to approve P. O. Wilhite, Tax Collector and Assessors' monthly report: All members voted "Aye" motion carried.

IN THE MATTER OF INCREASING SALARY OF WALTERRENE OWENS, DEPUTY TAX COLLECTOR & ASSESSOR.

Motion by Commissioner Taylor to grant application of P. O. Wilhite, Tax Assessor-Collector, for authority to increase the salary of Walterrene Owens, Clerk, from \$100.00 per month to \$125.00 per month, was seconded by Commissioner Goodwin. The motion was submitted by Judge Dickson, Commissioners, Taylor, Goodwin, Nugent and Banks voted "Aye". motion carried.

IN THE MATTER OF PURCHASING A FORD TRACTOR FOR TERRACING.

Motion by Commissioner Goodwin seconded by Commissioner Taylor that the Commissioners Court of Titus County, Texas purchase a Ford Tractor with Disc Terracing plow and Hydro Scoop, for the purpose of terracing farm and pasture land for farmers of Titus County. Machinery to be paid for out of the Road and Bridge fund. That the County Court by County Judge shall make application to the War Production Board for authority to purchase the above described machinery.

The motion was submitted by County Judge, Commissioners Goodwin, Taylor and Banks voted "aye". Commissioner Nugent was absent, therefore not voting. County Judge declared the motion carried.

IN THE MATTER OF PURCHASING AN INTERNATIONAL TRACTOR FOR TERRACING.

Motion by Commissioner Goodwin seconded by Commissioner Taylor that the Commissioners Court of Titus County, Texas, purchase one International Tractor model M. with whirl wind terracing Unit, for the purpose of terracing farm and pasture land for farmers of Titus County. Machinery to be paid for out of Road and Bridge Fund. That the County Court by County Judge shall make application to the War Production Board for authority to purchase the above described machinery.

The motion was submitted by County Judge. Commissioners Goodwin, Taylor and Banks voted "Aye". Commissioner Nugent was absent, therefore not voting. County Judge declared the motion carried.

There being no further business motion by Commissioner Banks, seconded by Commissioner Goodwin to adjourn until regular Session, July 10, 1944. All members voted "Aye".
