IN THE MATTER OF ORDER FOR ELECTION FOR COUNTY OPTIONAL ROAD LAW:

ORDER FOR ELECTION  
(Optional County Road Law of 1947)

THE STATE OF TEXAS :

COUNTY OF TITUS :

On this the 23 day of July, 1947, the Commissioners' Court of Titus County, Texas, convened in Special called session at the regular meeting place thereof at the Courthouse in Mt. Pleasant, Texas, with the following members of the court, to-wit:

being present and among other proceedings had by said Court was the following:

There came on to be considered the petition of J. C. Stinson and 317 other persons asking that an election be ordered upon the proposition of adopting "The Optional County Road Law of 1947".

It appearing to the satisfaction of the court that the number of qualified voters of the said county signing said petition is 10% or more of the number voting for governor at the last preceding general election in said county and is otherwise in conformity with law.

It further appearing to the Court that it is advisable and to the best interest of said County to submit said proposition to the qualified voters of said County and said election as prayed for shall be ordered.

THEREFORE, BE IT ORDERED BY THE COMMISSIONERS' COURT OF TITUS COUNTY, TEXAS:

That an election be held in said County on the 23rd day of August, 1947, which is not less than 30 days nor more than 60 days after the date the above mentioned petition was filed with this Court, at which election, in accordance with said petition, the following proposition shall be submitted to the qualified voters of said County for their action thereupon:

PROPOSITION

"Shall the County of Titus, State of Texas, adopt the terms and provisions of Senate Bill Number 226, Acts 1947, 50th Legislature, Regular Session, known as "The Optional County Road Law of 1947."

The ballots of said election shall have written or printed thereon the following:

"FOR THE OPTIONAL COUNTY ROAD LAW OF 1947"

"AGAINST THE OPTIONAL COUNTY ROAD LAW OF 1947"

Each voter shall mark out with black ink or black pencil one of the above expressions, thus leaving the other ad indicating his vote.

The manner of holding said election shall be governed by the General Election Laws of this State and none but qualified voters of said County shall be allowed to vote at said election.

Notice of said election shall be given by publication of a copy of this order in a newspaper of general circulation published in Titus County, Texas, on the same day in each of three successive weeks, the date of the first publication to be not less than 21 days prior to the date set for said election, and in addition thereto, a copy of this order shall be posted in each of the election precincts for said election and also at the County Courthouse at least 30 days prior to the date of said election.

The County Clerk is hereby authorized and directed to cause said notice to be published and posted as hereinabove directed and further orders are reserved until the returns of said election are made by the duly authorized election officials and received by this Court.

The above order being read, it was moved and seconded that same do pass. Thereupon the question being called for, the following members of the Court voted AYE: R. W. Jones, Eugene Mankins and Morris Holston. Commissioners Moore and Ponder absent-- not voting.

PASSED, APPROVED AND ADOPTED, this the 23 day of July, 1947.
