IN THE MATTER OF CLOSING ROAD:

: Notion made by Commissioner Moore and seconded by Commissioner Mankins that whereas the Ellis

Bridge Road situated in Precinct Number 4 was not being used by the public and that the people living near said road were using other roads and that there was no necessity of keeping said road open and that it would be advantageous to the County that said road be closed and

abandoned from Roy Nelson's place going east and south to the property of Mrs. V. F. Walker, about 125 yards from State Highway No. 67, but that said road remain open from Highway No. 67 to Mrs. Walker's home. Upon being put to a vote by the County Judge, said motion unanimously carried and said road was declared closed.

IE THE MATTER OF SECURING RIGHT-2-WAY FROM C. B. HARRIS, ET UX:

Motion made by Commissioner Mankins and seconded by Commissioner Fonder that the County pay to Mr. & Mrs. C. B. Harris out of the right-a-way fund the sum of \$185.00 for and in consideration of the said parties executing a right-a-way deed on the Wilkinson Farm to Market Road

and removing their fences and any other obstructions on their property back to the lines satablished by the State Highway Department in surveying said road and that the County Treasurer pay over said cum of money upon the execution of the deed and the removal of the obstructions. Upon being put to a vote, said motion unanimously carried.

IN THE MATTER OF TRANSFERRING ROAD AND BRIDGE FUNDS:

Motion made by Commissioner Moore and seconded by Commissioner Ponder that whereas the Titus County Equipment Fund, Titus County Maintenance Fund, Titus County Terracing Account and Wilkinson Bridge funds all are a part of the road and bridge fund that all monsy in each be transferred over to the regular Titus County Road and Bridge Fund and that the Treasurer be ordered to effect such transfers. Upon being put to a vote, said motion unanimously carried,

IN THE VATTER OF TRANSFERRING \$6,000.00 FROM OPERATING FUND TO GENERAL COUNTY FUND:

Ection by Commissioner Ponder and seconded by Commissioner Moors that the County Treasurer be ordered and authorized to transfer the sum of \$6,000.00 from the operating fund and deposit same in the General County Fund. Upon being put to a vote said motion unanimously carried.

IN THE MATTER OF TRANSFERRING FUNDS FROM ROAD AND BRIDGE FUND TO PRECINCT ROAD FUNDS:

Kotion made by Commissioner Jones and seconded by Commissioner Mankins that \$5,000.00 be withdrawn from the Road and Bridge fund and placed in the Precinct funds on the following basis:

Precinct One Road & Bridge Fund \$1,400.00; Precinct Two Road & Bridge Fund \$1,200.00;

Precinct Three Road & Bridge Fund \$1,400.00; Precinct Four Road & Bridge Fund \$1,000.00.

Upon being put to a vote, said motion carried unanimously.

There being no further business before the Court, Motion made by Commissioner Mankins and seconded by Commissioner Moore to adjourn. Motion carried.
