 IN THE MATTER OF SETTING TAX RATE FOR THE YEAR 1949:

Motion was made by Commissioner Jones and Seconded by Commissioner Mankin to set the County Tax Levy for the year 1949 on the One Hundred Dollar valuation as follows:
