TO THE HONORABLE COMMISSIONERS' COURT OF SAID COUNTY:

The undersigned freeholders in Precinct No. 1, in said county, citizens of said Precinct and county, represent that the hereinafter described road has served its purpose and is no longer needed as a public road; that it has ceased to be used by the public due to the fact that other roads have been constructed which serve the public properly and that said road sought to be closed has not been maintained by the County for some time; that it would be to the best interest of the public to close said road. Said road sought to be closed is described as follows: Being a part of what is commonly known as the Old Clarksville Road and the part to beclosed begins at a point where the road crosses the North Boundary line of the Bridges' Land and the South Boundary line of an 80.2 acre tract of land known as the J. W. Hinton land and which is now owned by C. M. Phillips. Said road is approximately 40 feet wide and extends in a Northwesterly direction across the C. M. Phillips Land and ending at a point where said

road crosses the West Boundary line of the Phillips land. The Phillips land is located in the Berry Merchant Survey, Abstract No. 359, Titus County, Texas and more fully described in a deed dated February 26, 1946 from W. D. Phillips to C. M. Phillips recorded in Vol. 150 page 657 of Deed Records of Titus County, Texas, reference to which is here made for all purposes. It is sought to close only that portion of the Old Clarksville Road which crosses the Southwest portion of the Phillips land which is in Precinct No. 1.

WHEREAS, this Court has heretofore determined the advisability and necessity of purchasing certain road machinery and equipment for use on the roads of Titus County, and purchasing right-of-way for public roads in the County, and constructing permanent road and bridge improvements in said County; and,

WHEREAS, this Court has heretofore determined the advisability and necessity of issuing interest bearing time warrants against the Road and Bridge Fund of said County to pay claims to be incurred in purchasing road machinery and equipment for use on the roads of Titus County, and purchasing right-of-wayfor public roads in the County, and constructing permanent road and bridge improvements in said County; and,

WHEREAS, this Court has heretofore on October 10, 1949, passed an order authorizing the issuance of \$135,000 TITUS COUNTY ROAD AND PRIDGE WARRANTS to pay claims to be incurred by the County for the above mentioned purpose; and,

WHEREAS, this Court, by resolution adopted on November 14, 1949, authorized, ordered and directed the County Judge to give notics to bidders on certain road machinery, and of the intention of the Commissioners Court to pay all or a part of the net cost of said machinery by the issuance and delivery of TITUS COUNTY ROAD AND BRIDGE WARRANTS, dated November 1, 1949, authorized by the order adopted on October 10, 1949; and,

WHEREAS, this Court affirmatively finds that said notice was duly given by publication in a newspaper of general circulation published in Titus County, in the manner and for the time provided by law; the date set for receiving bids being this December 12, 1949; and,

WHEREAS, this Court further finds that no petition of any kind or character in respect to the purchase of said road machinery described in said notice to bidders or the issuance and delivery of said Road and Bridge Warrants to pay all or a part of the net cost thereof, has been filed with the County Clark, or any member of this Court, or any other official thereof: and

WHEREAS, this Court has heretofore opened and considered the bids for the purchase of said road machinery; and,

WHEREAS, said bids having been found to be in proper order and accompanied by the required deposits, and the Commissioners Court desiring to award contract to the lowest and best bidder; now-

THEREPORE, WE IT ORDERED, ADJUDGED AND DECREED BY THE COMMISSIONERS COURT OF TITUS
COUNTY, TEXAS:

I.

That the following bid be accepted and contract awarded as follows:
