The Hon. Harry Taylor, County Judge, is hereby appointed as Agent of such county to execute all necessary agreements and instruments for and in behalf of the Titus County Memorial Hospital, an instrumentality of Titus County, Texas.

It is further ordered that a sufficient sum of money be allocated and set aside from the proper fund and to be known as the Titus County Memorial Hospital Social Security Fund for the purpose of carrying out the provisions of the above mentioned sets. Such Social Security Fund shall be set aside and maintained in the Titus County Memorial Hospital Depository. All funds placed into the said Social Security Fund to some from the Operating Fund of said Hospital.
