 IN THE MATTER OF TRANSFER:

Motion was made by Commissioner Roper and seconded by Commissioner Banks to transfer \$6535.64 from Prect. #2 to Prect. #1. Motion carried.

 IN THE MATTER OF TRANSFER

Motion was made by Commissioner Ponder and seconded by Commissioner Mankins to transfer \$5242.88 from Prect #4 to Prect #3. Motion carried.

 IN THE MATTER OF TRANSFER

Motion was made by Commissioner Mankins and seconded by Commissioner Ponder to transfer \$1500.00 from Prect #3 to General County. Motion carried.

NORTH MT. PLEASANT

This box is to be divided by U. S. Highway 271, with all residents living to the east of the road remaining in Precinct 15 and continuing to vote at the American Legion Hall.

Residents of the precinct living to the west of the road would form Precinct No. 16 and would vote at the Old Mays Funeral Home.

NORTHWEST MT. PLEASANT

Due to a concentration of population in this precinct, the court feels it should be divided into three precincts. This plan has been ascertained as most acceptable:

Precinct No. 13 would include that area bounded on the east by North Jefferson Ave; on the north by west twelfth; on the west by Edwards Ave., and on the south by West First Street. Residents would continue to vote at the tax office in the courthouse.

Precinct No. 17 to be bounded on the east by Edwards Ave. (all the way from West First to U. S. Highway 67); on the north by U. S. 67; on the West by Tankersley Creek, and on the south by West First and the Old Winfield Road. Residents of this area would vote at West Ward School.

Precinct No. 18 would be made up of all of the remaining part of what is now known as Northwest Mt. Pleasant voting box. It would be bounded on the east by Tankersley Creek and would include the Farmer's Academy community. Voters would cast their ballots at the Farmers Academy school house.

SOUTHWEST MT. PLEASANT

This precinct to be divided by an east-west line along West Cross Street to South O'Tyson Avenue and on to the Monticello Road. Residents living to the north of this line would continue to vote in the county superintendent's office at the courthouse. Residents to the south of this line would form Precinct No. 19, and for the time being, at least would vote in the office of the county treasurer in the courthouse, due to the fact at the present time there is no suitable building in the precinct in which balloting could take place.

SOUTHEAST MT. PLEASANT

This precinct can easily be divided by the Dalgnerfield Highway. Residents to the south would be grouped into Precinct No. 20 and they would cast their ballots at the South Ward School.

Residents to the north, in the precinct, would continue to vote in the County Agent's office at the courthouse.

NORTHEAST MT. PLEASANT

The growth of Danman Addition has made the division of the precinct necessary. The dividing line would begin at East First Street and would run northward along Danman Drive and across open country to U. S. Highway 67. Residents to the east would form No. 21 and would vote at the new East Ward School, which is expected to be ready by the summer of 1958.

Residents to the west of the north-south dividing line would continue to vote in the office of the county clerk at the courthouse.

TALCOO

It has been deemed advisable that Talcoo, for voting purposes, be divided by an east-west line following Farm to Market Highway 71. Residents living to the north of this line would continue to vote at the Talcoo city hall. Residents to the south of the line would vote at Calvary Baptist Church.

The above and foregoing minutes were read and approved this the 30th day of September, 1957.
