IN THE MATTER OF APPROVING COUNTY TREASURERS MONTHLY REPORT:

Motion was made by Commissioner Ponder and seconded by Commissioners Mankins to approve County Treasurers monthly report. Motion carried.

IN THE MATTER OF APPROVING OFFICERS MONTHLY EXPENSES:

Metion was made by Commissioner Roper and seconded by Commissioner Banks: to approve officers monthly expenses. Motion carried.

IN THE MATTER OF ACCEPTING THE PROVISIONS CONTAINED IN MINUTE ORDER 43002:

Motion was made by Commissioner Banks and seconded by Commissioner Ponder that the Titus County Commissioner's Court accept the provisions contained in Minute Order 43002 of the Texas State Highway Commission passed on Oct. 31, 1957, designating the extension of P.M. 2348 to State Highway 11, a distance of approximately 5.8 miles. Motion carried.

## ORDER

ON THIS, the 11th day of November, 1957, came on to be considered by the Commissiones Court of Titus County, Texas, at a regular term of such Court, the matter of the creation of a joint airport soning board to exercise the powers authorized such boards by the provisions of Chapter 391 of the Acts if the Regular Session of the 50th Legislature, 1947, to adopt administer and enforce airport soning regulations applicable to airport hazard areas in this County; and it appearing to the Court that on the 5th day of November 1957, the City Countil of the City of Mt. Pleasant, did enact its ordinance creating such a joint airport soning board, to be known as the Mt. Pleasant Joint Airport Zoning Bosrd, and which ordinance was expressly made subject, for its effectiveness, to a like provision being made by the Commissioners' Court of Titus County, Texas, and it further appearing to the Court that the creation of such a joint airport soning board is in the public interest of this County;

It is accordingly ORDERED, and there is hereby created, the Mt. Pleasant Joint Airport Zoning Board, which Board shall have the powers and exercise the duties set forth in Sections 2 and 3 of Chapter 391 of the Acts of the Regular Session of the 50th Legislature, 1947.

It is further ORDERED that the Mt. Pleasant Joint Airport Zoning Board shall be composed of five (5) members, two (2) to be appointed by the City Council of the City of Mt. Pleasant, Texas, and two (2) members to be appointed by this Commissioners: Court. The fifth member shall be elected by a majority of the members so appointed and said fifth member shall serve as chairman of the said Mt. Pleasant Joint Airport Zoning Board.

It is further ORDERED that Howard Leftwich and James Adams are hereby appointed as the County's members on said Mt. Pleasant Joint Airport Zoning Board.
