IT IS THEREFORE CONSIDERED AND ORDERED by the Court that an election be held in said County on the 8th day of December, 1959, which is not less than thirty (30) days from the date of this order, to determine whether or not the bonds of said County shall be issued

of the assessed valuation of the real property of said Titus County:

in the amount of One Hundred Thousand Dollars (\$100,000.00), for the purpose of the construction, maintenance and operation of macadamised, graveled or paved roads and turnpikes, or in aid thereof, in said County; bearing interest at a rate not to exceed five per cent (5%) per annus, and maturing at such times as may be fixed by the Commissioners\* Court, serially or otherwise, not to exceed twenty (20) years from the date thereof; and whether or not an ad valorem tax shall be levied upon all the taxable property in Titus County for the purpose of paying the interest on said bonds and to provide a sinking fund for the redemption thereof at maturity.
