authorising the issuance of \$100,000 TYLER COUNTY PERMANENT IMPROVEMENT WARRANTS, SERIES 1961.

dated May 15, 1961, bearing five per cent (5%) interest per annum, and maturing \$5,000 on May 15th in each of the years 1978 to 1987, inclusive, and \$10,000 on May 15th in each of the years 1988 to 1992, inclusive; for the purpose of evidencing the indebtedness to be incurred in constructing repairs and improvements to the County Courthouse, and for necessary expenses incidental thereto; and

MHEREAS, the Commissioners' Court now deems it necessary and proper to give notice to bidders for the construction of such repairs and improvements to the County Courthouse and of the County's intention to pay all or a part of the contract price by the issuance and delivery of warrants out of the above described series of warrants;

THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS! COURT OF TITUS COUNTY, TEXAS:

That the County Judge be end he is hereby authorized, ordered and directed to do all things necessary and/or convenient to have published the notice required by Chapter 163, Acts of the Regular Session of the Forty-second Legislature of Texas, as amended; that said notice shall specify the time and place when and where bids will be received, and said notice shall be published in a newspaper of general circulation published in said County once a week for two consecutive weeks prior to the time set for receiving bids, the date of the first publication to be at least fourteen (14) full days prior to the date set for receiving bids.

That said notice shall provide that all bids shall be accompained by a cashier's or certified check or acceptable bidders' bond in the amount of five per cent (5%) of the total bid; that said notice shall also convey the information that it is the intention of the County to pay all or a part of the contract price by the issuance and delivery of Titus County Permanent Improvement Warrants, Series 1961, bearing interest at the rats of five per cent (5%) per amount, and having a maximum maturity date of 1992, heretofore authorised by the Commissioners' Court in the maximum amount of \$100,000.00 for the purpose of evidencing the injebtedness to a incurred in construction repairs and improvments to the County Courthouse, and for necessary expenses incidental thereto.
