 IN THE MATTER OF BUYING OR ACCEPTING OF BIDS ON COUNTY MACHINERY:

Motion was made by Commissioner Parr and seconded by Commissioner Raney to accept the bid of Bob Sandlin Chevrolet Co. for a new truck for Precinct #2. The bid being \$3400.00 fully equipped, with a trade in of \$550.00 for the 1957 Chevrolet truck. This being a net bid of \$2850.00. Motion carried.

 IN THE MATTER OF BUYING OR ACCEPTING OF BIDS ON COUNTY MACHINERY:

Motion was made by Commissioner ~~XXXX~~ McAnally and seconded by Commissioner Bynum to accept the bid for a new case crawler loader Model 750. The list price F. O. B. Mt. Pleasant, Texas being \$14,500.00 and a trade in of the old Hough Loader of \$2,500.00. Being a net cost of \$12,000.00. Motion carried.
