 IN THE MATTER OF APPROVING BONDS FOR ELECTED OFFICIALS:

Motion was made by Commissioner Parr and seconded by Commissioner Raney to approve Bonds for the following officials: Pat Beck, Rayford Taylor, Tully R. Florey, III, Eugene Morris, T. O. Raney, John W. Terrell, Leon Rhea and Jim Talley. Motion carried.

 IN THE MATTER OF DEPOSITORY AND FUEL FOR COUNTY:

Motion was made by Commissioner Raney and seconded by Commissioner Morris that County Clerk advertise for bids for County Depository for the year of 1969 and 1970. Also, for Ethel Gasoline and Diesel Oil for 1969. Motion carried.

 IN THE MATTER OF VETERANS SERVICE OFFICER:

Motion was made by Commissioner Morris and seconded by Commissioner Parr to appoint W. R. Camlin as Veterans Service Officer for Titus County. Said appointment effective as of December 1, 1968. Salary for Service Officer to be \$125.00 per month (days of work to be Wednesday, Thursday and Friday of each week). Motion carried.

 IN THE MATTER OF INCOME FOR COMMODITY RECEIPIENTS:

Motion was made by Commissioner Raney and seconded by Commissioner Morris that the maximum amount of income for Commodity Recipients shall be as follows: 1 person \$90.00, 2 persons \$150.00, 3 persons \$165.00, 4 to 5 persons \$180.00, 6 to 7 persons \$190.00, 8 to 9 persons \$200.00, no family shall exceed \$200.00. Motion carried.

 IN THE MATTER OF ROAD HANDS SALARY:

Motion was made by Commissioner Morris and seconded by Commissioner Raney to raise road hands salary as follows: The \$1.73 per hr employes raised to \$1.85 per hr and the \$1.90 per hour employes to \$2.05 per hour. Motion carried.
