 - D. Hire such mowing done around the park area that is necessary.
 - Turn over all monies collected twice weekly to the Titus County Treasurer's Office. Establish a system and keep an account of all entries into the park.
- C. Make necessary improvements with prior approval of the Commissioner's Court, as to parking area, eating area, boating area and the general road system inside the park.
