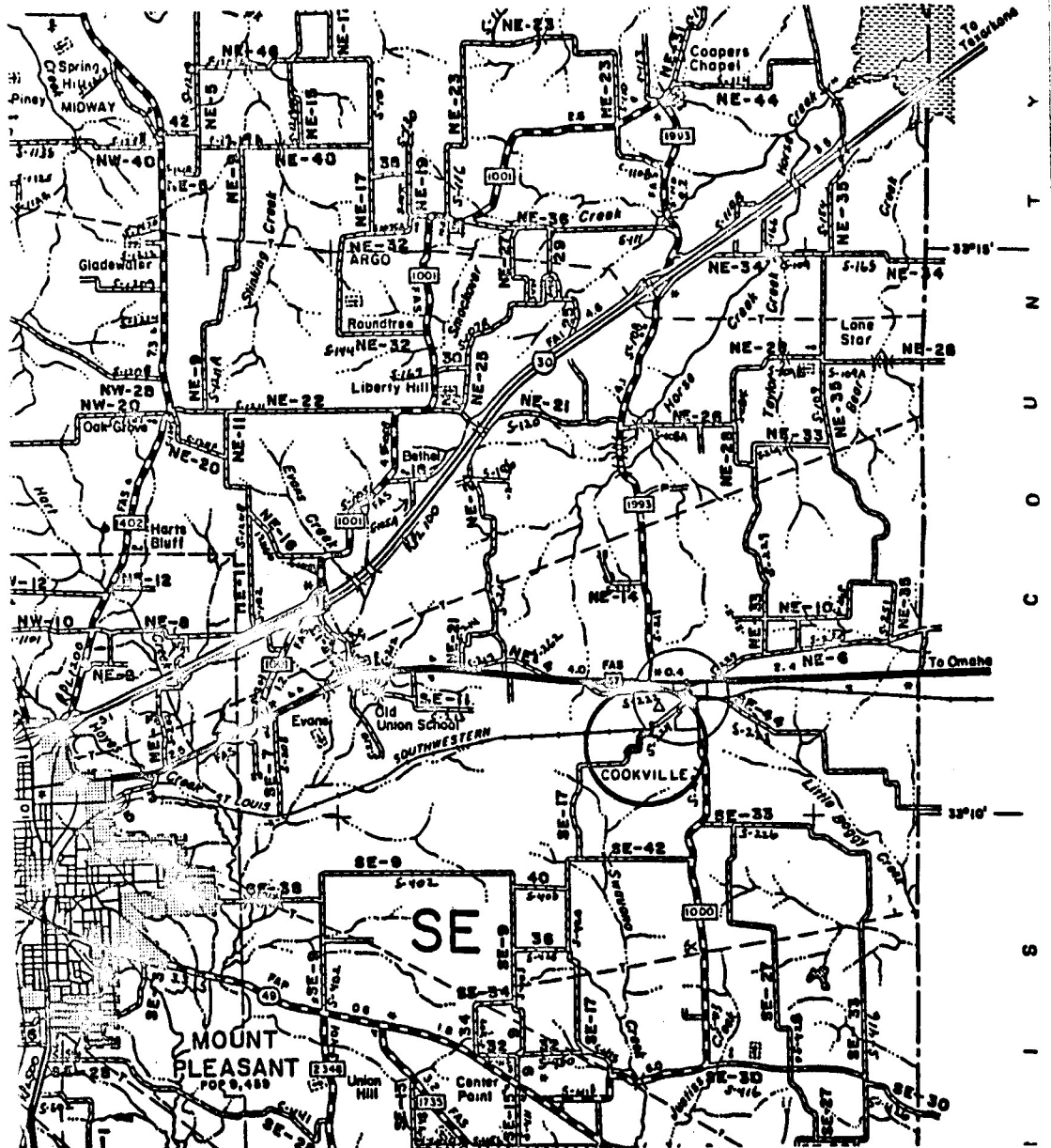

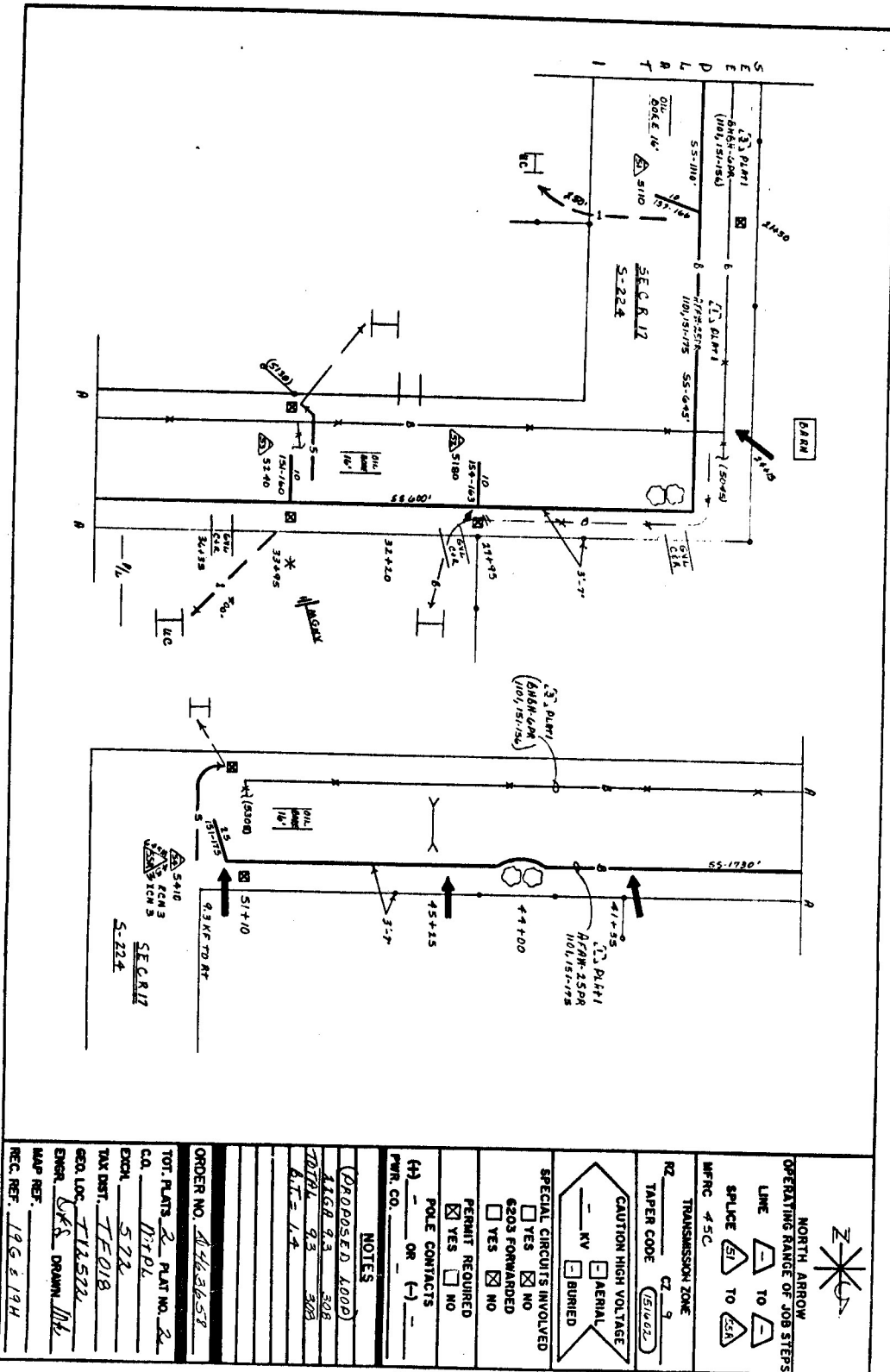
COUNTY PERMIT MAP

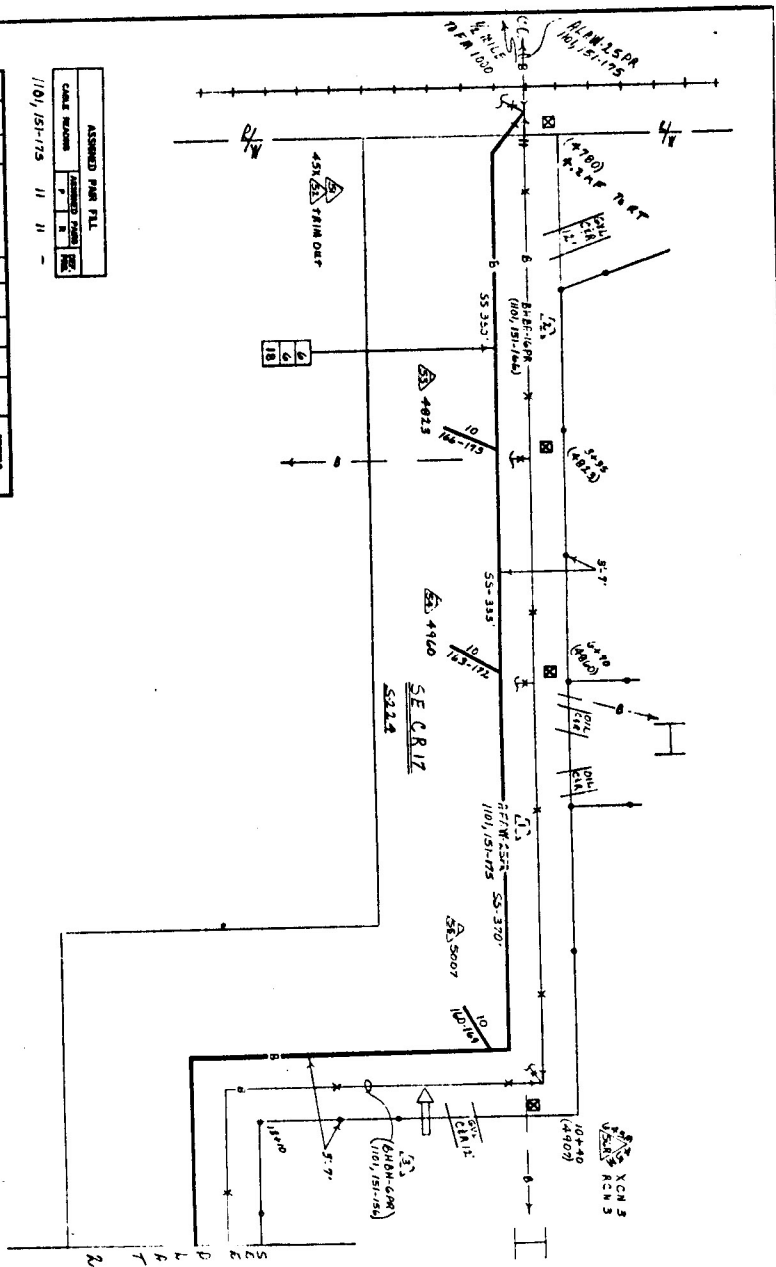
