SECTION 9: INCIDENT COMMAND

The Mount Pleasant Fire Chief or his designee shall have overall command at any incident that Mount Pleasant Fire Department Personnel and/or equipment are present. This shall apply only to unincorporated areas of Titus County.

EXHIBIT D

SECTION 1: FIRE DISTRICTS FOR TITUS COUNTY

Fire Districts for Member Cities' fire departments are hereby established as identified and set forth in "Exhibit D-1", attached hereto and incorporated herein for all purposes. Member Cities' fire departments will be responsible for and have control for all incidents occurring within their fire districts, as identified and set forth in said Exhibit D-1. This shall be true unless Mount Pleasant Fire Department Personnel and/or equipment are present. In such a case the Mount Pleasant Fire Chief or his designee shall have overall command. This shall apply only to unincorporated areas of Titus County.

I would also recommend that the County consider the type and amount of training firefighters have that respond to incidents in the County. The Mount Pleasant Fire Department has the first meeting night of the month designated for training of firefighters in our Department as well as any and all other firefighters in Titus County to attend. It is broadcast on the "All County Fire Page" as well as Talco and Winfield Fire Department radio frequency.

This has not met with much success as only one or two firefighters from outside our Department attend.


