**IN THE MATTER OF  
APPROVING PURCHASE OF 3 NEW CARS  
FOR SHERIFF'S DEPARTMENT**

Sheriff Ricky Poole said, "I would like the Court to consider allowing my department the opportunity to purchase 3 new cars from Randall Noe Ford-Mercury, Inc. out of Terrell, Texas. These cars are part of the state contract and can be purchased at a lower cost to the County. However, I need to purchase them now before budget time in order to save the County approximately \$9,000.00. The money we save on the cars will cover all the necessary equipment needed for the cars. That's just like getting the equipment free. I believe in saving the taxpayers as much money as I can. Each of these units will cost \$18,300.00."

Motion was made by Commissioner Mike Price and seconded by Commissioner Mike Fields to approve the purchase of 3 new cars for the Sheriff's Department from Randall Noe Ford-Mercury, Inc. of Terrell, Texas at the cost of \$18,300.00 each unit. Motion carried unanimously. SEE ATTACHMENT "A"

IN THE MATTER OF  
APPROVING BUDGET AMENDMENT

Motion was made by Commissioner Mike Price and seconded by Commissioner Billy J. Thompson to approve the budget amendment number #64 for the Sheriff's new cars. Motion carried unanimously.

Commissioner Mike Fields said, "I would like to report on the City - County Sale to be held on Saturday, July 26, 1997. I will be working with the sale. We need to ask each department if they have things that they want to put in the sale."

Sharon Reynolds Assistant Auditor said, "We need to ask each official to be sure and keep all serial and model numbers of all items placed in the sale. This will help us and them keep up with their inventory."

Sheriff Ricky Poole said, "I would like to know the feeling of the Court about donating the racks and wire baskets that were used in the old jail for inmates storage. I would like to donate them to the Junior High for their athletic department or wherever they could use them. I see no reason for us to sell them when the school could use them. Again, we would be saving taxpayer dollars."

The Court all agreed they saw no problem in donating the racks and wire baskets to the Junior High School Campus.

County Judge, Crooks said, "I have been approached by the Texas Department of Public Safety about helping build a fence between County property and the DPS Office. What are your feelings about this matter?"

Commissioner Thomas E. Hockaday said, "I don't see a problem with that, but it would need to be done at some of our slow time. Right now all our

road crews are busy trying to get all our road work done while we have the weather on our side. We will try to do this later."

County Judge Crooks asked, "Is there anything else we need to discuss. If not do I hear a motion to adjourn?"
