RE; PLAN DOCUMENT

Dear Judge Crooks:

As you may recall, when Gail Norris met with Titus County during the renewal process prior to the January 1, 2003 renewal, she advised that Titus County needed to revise and restate their Plan Document. The Department of Labor regulations state that the summary plan description (the booklet which is distributed to all employees and which is actually a part of your Plan Document) should be updated every five (5) years if the plan has been amended. The current Plan Document for Titus County was revised in 1998 which is within the five (5) year period; however, this was prior to going under the PPO plan effective January 1, 2000. The benefits, of course, changed considerably at that time and other amendments have also been made since then. It is always recommended that a Plan Document be revised and restated when there are material changes to the Plan.

We use a consultant to prepare the Plan Documents for our clients, and the fee is approximately \$1,500. Final cost will depend on number of revisions that have to be made to the first proof so I cannot give you an exact figure. I know you will have to get this approved by the Commissioners' Court so if you need any additional information, please let me know.
